ORDER OF FINAL JUDGEMNT  
BY DEFAULT

The Defendant, Matthew Nackson ("Defendant"), having been duly served with a copy of the Summons and Complaint in the above-entitled action and having been defaulted for failure to appear, answer or otherwise defend;

This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, specifically N.J.S.A. 17:33A-4(a)(1), by knowingly providing false and misleading statements to Progressive Garden State Insurance Company

("Progressive") in support of an insurance application and a third-party claim.

FINAL JUDGMENT is on this 13th day of September 2019, entered in the amount of \$9,635.00 against Defendant Matthew Nackson, and in favor of the Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$5,000.00 in civil penalties for two violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorneys' fees of \$3,500.00 pursuant to N.J.S.A. 17:33A-5; cost of service in the amount of \$135.00 pursuant to N.J.S.A. 17:33A-5; and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 39:6A-15, Defendant's driving privileges shall be suspended for a period of one year from the date of this judgment.
