Defendant, Nadira Ahmed ("Defendant"), having been duly served with a copy of the Summons and Complaint in the abovecaptioned action, and default having been entered for Defendant's failure to appear, answer, or otherwise defend;

This Court now finds that Defendant (a) presented written statements in support of claims for payment or other benefit pursuant to an insurance policy knowing that the statements contained false or misleading information concerning material facts, and (b) prepared or made written statements intended to be presented to an insurance company in support of a claim for payment or other benefit pursuant to an insurance policy knowing that the statements contained false or misleading information concerning material facts, both in violation of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act").

Specifically, Defendant presented two fabricated rental car receipts to an insurance company for reimbursement for rental car expenses pursuant to an automobile insurance policy, in violation of N.J.S.A. 17:33A-4(a)(1) and N.J.S.A. 17:33A-4(a)(2).

FINAL JUDGMENT is on this **14th** day of **January** 2021, entered in the amount of \$15,517.46 against Defendant as follows:

1. In favor of Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance: \$10,000.00 in civil penalties for two (2) violations of the Fraud Act pursuant to N.J.S.A. 17:33A-5(b); attorneys' fees of \$3,234.00 pursuant to
