THIS MATTER HAVING BEEN opened to the Court on the application of Andrew J. Bruck, Acting Attorney General of New Jersey, (by Eleanor Heck, Deputy Attorney General, appearing), attorney for Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance, for an Order of Final Judgment by Default; and

WHEREAS, the Defendant, Mona Omar, has been duly served with a copy of the Summons and Complaint in this action and default having been entered for failure to appear, answer or otherwise defend;

This court now finds that Defendant, Mona Omar, violated the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 (the "Fraud Act"), specifically N.J.S.A. 17:33A-4(a)(4)(b) and N.J.S.A. 17:33A-4(a)(5) by knowingly presenting false and misleading statements and concealing a material fact in a policy application submitted to an insurance company..

IT IS on this 11 day of August, 2021,

ORDERED that FINAL JUDGMENT is entered in the amount of \$5,000.00 against Defendant, Mona Omar, and in favor of Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of: \$1,500.00 in civil penalties for one violation of the Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorney fees of \$2,500.00 pursuant to N.J.S.A. 17:33A-5(b); plus \$1,000.00 constituting the surcharge pursuant to N.J.S.A. 17:33A-5.1; and

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 7 days of the date hereof.
