This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, specifically N.J.S.A. 17:33A-4(a)(1) and -4(a)(3), N.J.S.A. 17:33A-4(a)(2), N.J.S.A. 17:33A-4(b), by providing false information to Plymouth Rock Assurance Preferred Corporation ("Plymouth Rock") on three separate occasions concerning the alleged theft of an automobile, and conspired with two other parties in furtherance of a false theft claim to Plymouth Rock in violation of New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act").

FINAL JUDGMENT is on this 22 day of Sept. 2023,

entered in the amount of \$39,862.50 against Defendant Hector L. Marquez, Jr., and in favor of the Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$30,000.00 in civil penalties for three violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorneys' fees of \$8,782.50 pursuant to N.J.S.A. 17:33A-5; cost of service in the amount of \$80.00 pursuant to N.J.S.A. 17:33A-5(b); and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1.
