The Defendant, Stacy L. Fannin ("Defendant"), having been duly served with a copy of the Summons and Complaint in the above-entitled action and having been defaulted for failure to appear, and the Court having granted Plaintiff's Motion for Enforcement of Settlement and Consent Judgment without opposition, answer or otherwise defend;

This Court now finds that the Defendant committed four violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"), specifically N.J.S.A. 17:33A-4(a)(1) and -4(a)(2) by presenting written and oral statements as part of a claim for payment pursuant to an insurance policy on four occasions knowing that the statements contained false or misleading information concerning facts material to the claim; and

FINAL JUDGMENT which shall be docketed as a state wide lien on this day of 2025, entered in the amount of \$24,625.00 against Defendant Stacy L. Fannin, and in favor of the Plaintiff, Justin Zimmerman, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$22,500.00 in civil penalties for four violations of the Fraud Act pursuant to N.J.S.A. 17:33A-5(b); attorneys' fees of \$1,125.00 pursuant to N.J.S.A. 17:33A-5(b); and a statutory fraud surcharge of \$1,000.00, pursuant to N.J.S.A. 17:33A-5.1; and
