This matter coming before the Court on the application of Matthew J. Platkin, Attorney General (by William E. Vaughan, Deputy Attorney General, appearing), attorney for the Plaintiff, Justin Zimmerman, Commissioner of the New Jersey Department of Banking and Insurance, for an Order Granting Summary Judgment against Defendant Yishaki A. Boozer; and the court having considered the papers submitted by counsel, and for good cause shown;

It is on this 17th day of October , 2025;

ORDERED that Summary Judgment be and is hereby GRANTED in favor of Plaintiff Justin Zimmerman, Commissioner of the New Jersey Department of Banking and Insurance, against Defendant, Yishaki A. Boozer; and

IT IS FURTHER ORDERED that for the reasons stated in Plaintiff's motion papers, this court now finds that Defendant Yishaki A. Boozer engaged in two (2) violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"). Specifically, Defendant Yishaki A. Boozer falsely represented in an April 22, 2022 application to Citizens United Reciprocal Exchange ("CURE"), and in a subsequent statement to CURE, that she was the only driver, licensed resident, or unlicensed resident in the household, concealing that Kamill Grate, an unlicensed driver, resided in the household; and

IT IS FURTHER ORDERED that after consideration of the factors relevant to the calculation of civil penalties, as set forth in <u>Kimmelman v. Henkels & McCoy, Inc.</u>, 108 N.J. 123 (1987), monetary penalties be and are hereby entered against Defendant Yishaki A. Boozer in the amount of \$5,000.00 pursuant to N.J.S.A. 17:33A-5(b), plus a \$1,000.00 surcharge pursuant to N.J.S.A. 17:33A-5.1; and

IT IS FURTHER ORDERED, that after consideration of the factors relevant for the assessment of attorneys' fees, as set forth in Rendine v. Pantzer, 141 N.J. 292 (1995), that judgment shall be and hereby is entered against Defendant Yishaki A. Boozer, for the payment of attorneys' fees in the amount of \$5,000.00 ___, pursuant to N.J.S.A. 17:33A-5(b); and

IT IS FURTHER ORDERED that Final Judgment be entered in the total amount of \$11,000.00 against Defendant Yishaki A. Boozer, and in favor of the Plaintiff, Justin

Zimmerman, Commissioner of the New Jersey Department of Banking and Insurance.
This amount consists of \$5,000.00 in civil penalties for two violations of the pursuant
to N.J.S.A. 17:33A-5(b); attorneys' fees of \$5,000.00 pursuant to N.J.S.A. 17:33A-5(b);
and a statutory fraud surcharge of \$1,000.00, pursuant to N.J.S.A. 17:33A-5.1; and
IT IS FURTHER ORDERED that a copy of this Order shall be deemed served on
all parties upon it being uploaded onto eCourts.
