ORDER AMENDING
FINAL ORDER
NO. E14-140
AS TO
JEFFREY BARKER GIBBS
ONLY

This matter, having been opened to the Commissioner of Banking and Insurance ("Commissioner"), State of New Jersey, upon information that Clear Advantage Title, Inc. ("Clear Advantage") and Edward Furfey ("Furfey") and Jeffrey Barker Gibbs ("Gibbs"), may have violated various provisions of the insurance laws of the State of New Jersey; and

WHEREAS, this Order amends Final Order No. E14-140, issued by the Commissioner on November 25, 2014; and

IT APPEARING that Final Order No. E14-140 ordered, among other things, the revocation of the insurance producer license of Jeffrey Barker Gibbs, Ref. No. 1045881 (hereinafter as "Gibbs"), and imposed civil penalties upon Gibbs for violations of the insurance laws of the State of New Jersey as alleged by the Commissioner in Order to Show Cause No. E13-14 dated February 19, 2013; and

IT FURTHER APPEARING that Order to Show Cause No. E13-14 mistakenly alleged that Gibbs committed violations of the insurance laws of this State and the resulting revocation of Gibbs' insurance producer license and the imposition of civil penalties upon Gibbs ordered in Final Order No. E14-140 were in error, due to mistaken identity; and

IT FURTHER APPEARING that the Commissioner desires to correct Final Order No. E14-140 to conform with these facts and issues this Order to amend and vacate Final Order No. E14-140 as to Jeffrey Barker Gibbs only;

NOW, THEREFORE, IT IS on this 20° day of 10° ,

ORDERED that the charges contained in Order to Show Cause No. E13-14 against Gibbs only are hereby dismissed; and

IT IS FURTHER ORDERED that all violations found and all penalties imposed upon Gibbs in Final Order No. E14-140, including revocation of his insurance producer license and all civil penalties and costs, are hereby VACATED as to Jeffrey Barker Gibbs ONLY; and

IT IS FURTHER ORDERED that all violations found and all penalties imposed upon Respondents Clear Advantage and Furfey in Final Order No E14-140 remain in full force and

effect, and are in no way disturbed by this Order; and

IT IS FURTHER ORDERED that the provisions of this Order represent a final agency decision and constitute a final resolution of the allegations contained in Order to Show Cause No. E13-14.
