This matter, having been opened by the Commissioner of Banking and Insurance (“Commissioner”), State of New Jersey, upon information that Amy Jankowski (“Respondent”), currently seeking a resident insurance producer license, pursuant to N.J.S.A. 17:22A-29, may have violated various insurance laws of the State of New Jersey; and

WHEREAS, the Respondent is subject to the provisions of the New Jersey Insurance Producer Licensing Act of 2001, N.J.S.A. 17:22A-26 et seq.; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40a (1), a producer shall not provide incorrect, misleading, incomplete or materially untrue information in the license application; and

IT APPEARING that on or about May 26, 1990, the Respondent was arrested and charged with Possession of CDS, a 3<sup>rd</sup> Degree Felony; and

IT FURTHER APPEARING, that the Respondent plead guilty in New Jersey Superior Court, Middlesex County to Possession of CDS on or about July 25, 1991; and

IT APPEARING that on or about September 30, 1990, the Respondent was arrested and charged with Conspiracy to Possess CDS, a 3<sup>rd</sup> Degree Felony; and

IT FURTHER APPEARING, that the Respondent plead guilty in New Jersey Superior Court, Middlesex County to Conspiracy to Possess CDS on or about February 28, 1992; and

IT FURTHER APPEARING that on February 23, 2016 the Respondent improperly answered "No" to the background question which asked "Have you ever been convicted of a felony, had a judgment withheld or deferred, or are you currently charged with committing a felony?" during her licensing examination to qualify for the Producer license, and confirmed the accuracy of her background question response when submitting her license application to the Department on or about April 22, 2016 in violation of N.J.S.A. 17:22-40a (1); and

IT FURTHER APPEARING, that the Respondent has admitted responsibility for the aforementioned violations;

IT FURTHER APPEARING, that the Respondent cooperated with the investigation conducted by the Department of Banking and Insurance; and

IT FURTHER APPEARING, that the Respondent asserted that the violation cited in this Consent Order was not willful; and

IT FURTHER APPEARING, that cause exists under N.J.S.A. 17:22A-40b to impose a fine; and

IT FURTHER APPEARING, that the Respondent has waived its right to a hearing on the aforementioned violations and consented to payment of a fine in the amount of \$1,000.00; and

NOW, THEREFORE, IT IS on the 20<sup>th</sup> day of, July 2016

ORDERED AND AGREED that the Respondent shall pay a fine in the amount of \$1,000.00 to the Department of Banking and Insurance by certified check, cashier's check or money order made payable to the State of New Jersey, General Treasury which shall be paid upon execution of this Consent Order by the Respondent; and

IT IS FURTHER ORDERED AND AGREED that the signed Consent Order together with the payment of \$1,000.00 shall be transmitted to:

IT IS FURTHER ORDERED AND AGREED, that in the event full payment of the fine is not made, the Commissioner may exercise any and all remedies available by law, including but not limited to recovery of any unpaid penalties in summary proceedings, in accordance with the penalty enforcement law at N.J.S.A. 2A:58-10 et seq.; and

IT IS FURTHER ORDERED AND AGREED, that the provisions of this Consent Order represent a final agency decision and constitute a final resolution of the violations contained herein; and

IT IS FURTHER ORDERED AND AGREED, that the Respondent shall cease and desist from engaging in the conduct that gave rise to this Consent Order.
