THIS MATTER, having been opened by the Commissioner of Banking and Insurance ("Commissioner"), State of New Jersey, upon issuance of Order to Show Cause No. E17-96 alleging that Respondent, Shannon Shaw ("Shaw"), may have violated various provisions of the insurance laws of the State of New Jersey; and

WHEREAS, Shaw was licensed as a resident insurance producer, pursuant to N.J.S.A. 17:22A-32, until her license expired on July 31, 2015; and

WHEREAS, Shaw is subject to the provisions of the New Jersey Insurance Producer Licensing Act of 2001, N.J.S.A. 17:22A-26 to -48 ("Producer Act"); and

WHEREAS, pursuant to N.J.S.A. 17:22A-40d, the Commissioner shall retain the authority to enforce the provisions of and impose any penalty or remedy authorized by the Producer Act and Title 17 of the Revised Statutes or Title 17B of the New Jersey Statutes against

any person who is under investigation for or charged with a violation of the Producer Act or Title 17 of the Revised Statutes or Title 17B of the New Jersey Statutes even if the person's license or registration has been surrendered or has lapsed by operation of law; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40a(2), an insurance producer shall not violate any insurance law, regulation, subpoena, or order of the Commissioner or of another state's insurance regulator; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40a(6), an insurance producer shall not be convicted of a felony or crime of the fourth degree or higher; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40a(18), an insurance producer shall not fail to notify the Commissioner within 30 days of his conviction of any crime, indictment or the filing of any formal criminal charges, or the suspension or revocation of any insurance license or authority by a state, other than this State, or the initiation of formal disciplinary proceedings in a state, other than this State, affecting the producer's insurance license; or fail to obtain the written consent pursuant to sections 1033 and 1034 of Title 18, Unites States Code (18 U.S.C. 1033 and 1034); or fail to supply any documentation that the Commissioner may request in connection therewith; and

WHEREAS, pursuant to N.J.S.A. 17:22A-47b, within 30 days of the initial pretrial hearing date, an insurance producer shall report to the Commissioner any criminal prosecution of the producer taken in any jurisdiction, which report shall include a copy of the initial complaint filed, the order resulting from the hearing and any other relevant legal documents; and

WHEREAS, pursuant to N.J.S.A. 17:22A-45c, any person violating any provision of the Producer Act shall be liable to a penalty not exceeding \$5,000.00 for the first offense and not exceeding \$10,000.00 for each subsequent offense; moreover, the Commissioner may order

restitution of moneys owed any person and reimbursement of costs of the investigation and prosecution, as appropriate; and

WHEREAS, the Commissioner issued Order to Show Cause E17-96 on October 20, 2017 alleging violations of New Jersey insurance laws by Shaw as set forth in the following Counts:

ALLEGATIONS COMMON TO ALL COUNTS

IT APPEARING, that from November 8, 2013 through January 7, 2014, Respondent was employed as a licensed insurance producer at the Affordable Insurance Agency in Haddon Township ("Affordable Insurance"); and

IT FURTHER APPEARING, that one of Respondent's duties at Affordable Insurance was to prepare applications for motor vehicle insurance coverage to be issued through the State of New Jersey's Special Automobile Insurance Policy Program; and

IT FURTHER APPEARING, that from November 8, 2013 through January 7, 2014, Respondent electronically submitted 33 applications to the State for Special Automobile Insurance Policies, indicating that payment would be made, and thereby binding coverage for the insured; and

IT FURTHER APPEARING, that in each of these 33 transactions Respondent misappropriated the \$185.00 initial premium payment provided to her by the applicant instead of forwarding the premium payment to the State; and

IT FURTHER APPEARING, that on or about November 5, 2014, Respondent pleaded guilty by Accusation No. 3361-11-14 charging her with third-degree Insurance Fraud, in violation of N.J.S.A. 2C:21.4.6a(2); and

IT FURTHER APPEARING, that Respondent failed to notify the Commissioner within 30 days that she had been formally charged with a crime; and

COUNT ONE

IT FURTHER APPEARING, that on or about February 6, 2015, Respondent was convicted of third-degree Insurance Fraud, in violation of N.J.S.A. 2C:21.4.6a(2), and was sentenced to three years' probation, ordered to pay a \$1,000.00 penalty to the State, ordered to pay restitution to Affordable Insurance in the amount of \$6,105.00, and ordered to forfeit her insurance producer's license for five years, which conviction constitutes a violation of N.J.S.A. 17:22A-40a(6); and

COUNT TWO

IT FURTHER APPEARING, that Respondent failed to advise the Commissioner of the filing of formal charges and subsequent conviction within 30 days, in violation of N.J.S.A. 17:22A-40a(18) and N.J.S.A. 17:22A-47b; and

IT FURTHER APPEARING, that as set forth in the certification of service of Ryan S. Schaffer, Deputy Attorney General, attached hereto as Exhibit "A," Shaw was given notice of the aforesaid charges and an opportunity to contest the charges at a hearing pursuant to Order to Show Cause E17-96, which was duly served on Shaw by certified and regular mail to the address listed on this Final Order in accordance with N.J.A.C. 11:17D-2.1(a)3; and

IT FURTHER APPEARING, that Shaw failed to provide written responses to the charges contained in Order to Show Cause E17-96 within 20 days as provided by N.J.A.C. 11:17D-2.1(d)1, and therefore Shaw has waived her right to a hearing to contest these charges and the charges are deemed admitted, pursuant to N.J.A.C. 11:17D-2.1(b)1;

NOW, THEREFORE, IT IS on this day of , 2018;

ORDERED, that the charges contained in Counts One and Two of Order to Show Cause E17-96 are deemed admitted by Shaw, pursuant to N.J.A.C. 11:17D-2.1(b)1; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-40, and N.J.A.C. 11:17D-2.1(b)2, the resident insurance producer license of Shaw is hereby **REVOKED** effective upon the execution of this Final Order by the Commissioner; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-45c, Shaw shall pay a civil penalty in the amount of \$5,000.00 to the Commissioner; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-45c, Respondent shall be responsible for the reimbursement to the Department of the costs of investigation totaling \$900.00. A true and exact copy of the Certification of Jared Stewart, Department of Banking and Insurance Investigator, is attached hereto as Exhibit "B"; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-45c, Shaw shall make restitution of \$6,105.00 to Affordable Insurance and provide proof of payment to Commissioner; and

IT IS FURTHER ORDERED, that Respondent shall pay the above penalties and costs to the Commissioner of Banking and Insurance, State of New Jersey, P.O. Box 329, Trenton, New Jersey 08625, Attention: Virgil Dowtin, Chief of Investigations, by certified check, cashier's check or money order made payable to the "State of New Jersey, General Treasury," within ten days from the date of service of this Order; and

IT IS FURTHER ORDERED, that in the event full payment of the penalty and costs is not made, the Commissioner may exercise any and all remedies available by law, including but not limited to recovery of any unpaid penalties, in accordance with the Penalty Enforcement Law of 1999, N.J.S.A. 2A:58-10 to -12; and

IT IS FURTHER ORDERED, that the civil penalty in this Final Order is imposed pursuant to the police powers of the State of New Jersey for the enforcement of the law and the

protection of the public health, safety and welfare, and is not intended to constitute debts which may be limited or discharged in a bankruptcy proceeding; and

IT IS FURTHER ORDERED, that the provisions of this Final Order represent a final agency decision and constitute a final resolution of the allegations contained in Order to Show Cause No. E17-96 as to Respondent Shannon Shaw.

We represent the New Jersey Department of Banking and Insurance ("Department"). Enclosed, please find Order to Show Cause No. E17-96 issued by the Director of Insurance on October 20, 2017.
