THIS MATTER, having been opened by the Commissioner of Banking and Insurance ("Commissioner"), State of New Jersey, upon issuance of Order to Show Cause No. E18-52, alleging that Respondent Hany Shehata d/b/a MHM Insurance Agency ("Respondent") may have violated various provisions of the insurance laws of the State of New Jersey; and

WHEREAS, Respondent is a licensed resident insurance producer in the State of New Jersey, pursuant to N.J.S.A. 17:22A-32(a); and

WHEREAS, Respondent operated under the trade name MHM Insurance Agency; and WHEREAS, Respondent is subject to the provisions of the New Jersey Insurance Producer Licensing Act of 2001, N.J.S.A. 17:22A-26 to -48 ("Producer Act"), the Producer Licensing

regulations, N.J.A.C. 11:17-1.1 to -2.17, the regulations governing Insurance Producer Standards of Conduct, N.J.A.C. 11:17A-1.1 to 11:17D-2.8, and the Persons Employed in the Business of Insurance regulations, N.J.A.C. 11:17E-1.1 to -1.7; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40(a)(2), an insurance producer shall not violate any insurance law, regulation, subpoena, or order of the Commissioner or of another state's insurance regulator; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40(a)(4), an insurance producer shall not improperly withhold, misappropriate, or convert any monies or properties received in the course of doing business; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40(a)(8), an insurance producer shall not use fraudulent, coercive, or dishonest practices, or demonstrate incompetence, untrustworthiness, or financial irresponsibility in the conduct of insurance business in this State or elsewhere; and

WHEREAS, pursuant to N.J.A.C. 11:17C-2.2(b), an insurance producer shall pay all premiums due to the insured or credit to the insured's account within five business days after receipt by the insurance producer from the insurer, or other insurance producer or premium finance company; and

WHEREAS, pursuant to N.J.A.C. 11:17C-2.3(a), an insurance producer shall establish and maintain a trust account into which shall be deposited cash, checks, and other instruments payable to the insurance producer; and

WHEREAS, pursuant to N.J.S.A. 17:22A-40(a), the Commissioner may place on probation, suspend, revoke, or refuse to issue or renew an insurance producer's license, and may levy a civil penalty, for a violation of the Producer Act; and

WHEREAS, pursuant to N.J.S.A. 17:22A-45(c), any person violating any provision of the Producer Act shall be liable to a penalty not exceeding \$5,000.00 for the first offense and not exceeding \$10,000.00 for each subsequent offense; additionally, the Commissioner may order restitution of moneys owed any person and reimbursement of costs of the investigation and prosecution, as appropriate; and

WHEREAS, the Commissioner issued Order to Show Cause E18-52 on May 25, 2018 alleging violations of New Jersey insurance laws by Respondent as set forth in the following Counts:

ALLEGATIONS COMMON TO ALL COUNTS

IT APPEARING, that L.C. purchased a home improvement insurance policy through Respondent; and

IT FURTHER APPEARING, that the home improvement insurance policy was written by Tapco Underwriters; and

IT FURTHER APPEARING, that Tapco Underwriters cancelled the policy on March 15, 2014 and forwarded the refunded premium in the amount of \$809.37 to Respondent; and

IT FURTHER APPEARING, that Respondent did not advise L.C. of the cancellation and did not refund the premium; and

IT FURTHER APPEARING, that on March 20, 2015, after learning about the refund L.C. filed a consumer complaint with the Department of Banking and Insurance, Consumer Protection Services Unit ("Department") against Respondent; and

IT FURTHER APPEARING, that on March 25, 2015, an investigator from the Department sent a letter to Respondent inquiring about the refund; and

IT FURTHER APPEARING, that on April 5, 2015, Respondent issued a refund check in the amount of \$809.00 to L.C. from a personal bank account; and

COUNT 1

IT FURTHER APPEARING, that Respondent failed to advise L.C. of cancellation of the policy, in violation of N.J.S.A. 17:22A-40(a)(8); and

COUNT 2

IT FURTHER APPEARING, that Respondent failed to forward to L.C. the refunded premium within five business days, in violation of N.J.S.A. 17:22A-40(a)(2), (4), and (8), and N.J.A.C. 11:17C-2.2; and

COUNT 3

IT FURTHER APPEARING, that Respondent failed to maintain a trust account, in violation of N.J.A.C. 11:17C-2.3; and

IT FURTHER APPEARING, that as set forth in the Certification of Brian R. Fitzgerald, attached hereto as Exhibit A, Respondent was given notice of the aforesaid charges and an opportunity to contest the charges at a hearing pursuant to Order to Show Cause E18-52, which was duly served on Respondent by certified and regular mail at his last known mailing address; and

IT FURTHER APPEARING, that Respondent failed to provide a written response to the charges contained in Order to Show Cause E18-52 within 20 days as provided by N.J.A.C. 11:17D-2.1(d)(1), and therefore Respondent has waived his right to a hearing to contest these charges and the charges are deemed admitted, pursuant to N.J.A.C. 11:17D-2.1(b)(1);

NOW, THEREFORE, IT IS on this 25 day of day

ORDERED, that the charges contained in Counts One, Two, and Three of Order to Show Cause E18-52 are deemed admitted by Respondent, pursuant to N.J.A.C. 11:17D-2.1(b)(1); and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-40, and N.J.A.C. 11:17D-2.1(b)(2), the resident insurance producer license of Respondent is hereby **REVOKED** effective upon the execution of this Final Order by the Commissioner; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-45(c), Respondent is responsible for the payment of civil penalties in the amount of \$25,000.00 for the violations of the Producer Act and other regulations cited above as follows:

Count 1: Respondent shall pay a civil penalty of \$5,000.00; and

Count 2: Respondent shall pay a civil penalty of \$10,000.00; and

Count 3: Respondent shall pay a civil penalty of \$10,000.00; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 17:22A-45(c) and N.J.A.C. 11:1-32.4(b)(20), Respondent shall reimburse the Department of Banking and Insurance for the costs associated with the investigation and prosecution of this matter, as evidenced by the Certification of Costs by Daxesh Patel, attached hereto as Exhibit B, totaling \$487.50.

IT IS FURTHER ORDERED, that Respondent shall pay the above penalties and costs totaling \$25,487.50 in full by remitting payment to the Commissioner of Banking and Insurance, State of New Jersey, P.O. Box 329, Trenton, New Jersey 08625, Attention: Virgil Dowtin, Chief of Investigations, by certified check, cashier's check, or money order made payable to the "State of New Jersey, General Treasury," within ten days from the date of service of this Order; and

IT IS FURTHER ORDERED, that in the event full payment of the penalty and costs is not made, the Commissioner may exercise any and all remedies available by law, including but not limited to recovery of any unpaid penalties, in accordance with the Penalty Enforcement Law, N.J.S.A. 2A:58-10 to -12; and

IT IS FURTHER ORDERED, that the civil penalties in this Final Order are imposed pursuant to the police powers of the State of New Jersey for the enforcement of the law and the protection of the public health, safety and welfare, and are not intended to constitute debts which may be limited or discharged in a bankruptcy proceeding; and

IT IS FURTHER ORDERED, that the provisions of this Final Order represent a final agency decision and constitute a final resolution of the allegations contained in Order to Show Cause No. E18-52.

We represent the New Jersey Department of Banking and Insurance ("Department"). Enclosed, please find Order to Show Cause No. E18-52 issued by the Director of Insurance on May 25, 2018. The Order to Show Cause charges you with various violations of the insurance laws and regulations of the State of New Jersey, and orders you to appear and show cause as to why your insurance producer licenses should not be suspended or revoked, and why other administrative fines and costs should not be imposed against you.
