1. April 24th Meeting Summary - CIGNA representative is Secretary, and was unable to attend.

2. Membership Secretary - Marc calling CIGNA. Serena Collado, had volunteered.

Public Member - Debbie Will call Bob Hoffman to inquire as to his availability. He would have to be appointed by Commissioner.

Mutual of Omaha - will let us know if they are going to participate.

Prudential/AARP - Prudential will let us know if they are going to participate.

3. HCFA - Marc reported:
We have made our submission to them. Time is of the essence in getting this program running.

HCFA says - no legislation on this subject this year, though that's what HCFA wanted us to wait for. (Federal legislation - all carriers required to offer under 65 Medicare Supplement).

Don reported that - "Individual turns 65 - go Into market" was our proposal.

HCFA ruled - has to be guaranteed renewable GR Rules changed and in register today. 30 day comment period (until November 7). Result - at 65, individual can go into market, but doesn't have to. If the individual stays on their plan, they stay in Under 50 pool.

We have to watch future federal legislation to make sure covered folks would be eligible.

4. Dates - January 1 plan to be effective. Letters to all Medicare Supplement carriers should be out October 7th, with response letters due back October 15. Board has to approve contract for contracting carrier by November 15. December - start enrolling for January 1, 1997 effective dates.

5. Board Membership

Commissioner - no vote Contracting Carrier -2 insurers - BL&C, Prudential HMO - CIGNA HIAA - Mutual of Omaha 2 public members - Victor and member to be appointed

6. Appointment of Contracting Carrier

Letter to insurance companies that are currently selling Medicare Supplement will go out this week. Includes: notice that companies have till October 15th to respond, notice of the program, invite to be approved as Contracting Carrier, and live target date is to be no later than January 1.

7. Contract - Blue Cross & Blue Shield of New Jersey will send draft to the carriers on the Board. They must respond in a timely manner, with comments from their legal staff and actuarial staff.

8. Plan of Operations

Commissioner must approve it once we submit it to the Department of Insurance.

Will be reviewed and revised today.
