The following reinsurers have complied with N.J.S.A. 17:51B-1 et. seq. and N.J.A.C. 11:2-28. Therefore, all insurers domiciled, licensed or eligible to write surplus lines insurance in New Jersey shall be allowed to take full credit for reinsurance ceded to the listed reinsurers when collateral is posted at the minimum required percentage until December 31, 2026.

Pursuant to N.J.A.C. 11:2-28.7B, the following named reinsurers qualified as “**Certified Reinsurers.**”
