WHEREAS. Respondent Tannenbaum admits that he acted in violation of N.J.S.A. 45:15-17(m) in that he accepted a commission as a real estate salesperson from a person other than his employing broker; and

WHEREAS Respondent Tannenbaum acknowledges that he has been made aware of his right to a full and formal hearing on any violations which the Commission may allege he has committed and his right to have the advice of counsel on the matters to which this Consent Order pertains, he is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Tannenbaum agrees to pay a fine in the amount of \$2500.00; and it is further ordered and agreed that

Respondent Tannenbaum shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

Respondent Tannenbaum agrees to take an additional 3 hour continuing education course in the area of agency which will not count towards the continuing education requirement for the 2017-2019 renewal term within ninety days of the approval of this consent order, and provide proof of completion to the Commission staff;

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding:
