WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Alexander has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Alexander have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Alexander acted with Eva Hrousis as the co-listing agents of the property located at 109 Main Street, Glen Gardner, New Jersey; and

WHEREAS Eva Hrousis, the co-listing agent, wrote on the top of the seller disclosure form "New Construction" when the property was, in fact, not new construction; and

WHEREAS Hrousis claimed that she wrote it at the direction of the home seller; and

WHEREAS as a co-listing agent Alexander shared responsibility for the transaction; and

WHEREAS Alexander admits that she acted in violation of N.J.S.A. 45:15-17(e), in competency, in that the co-listing agent wrote "new construction" on the seller disclosure form when it was not new construction; and

WHEREAS Respondent Alexander acknowledges that she has been made aware of her right to a full and formal hearing on any violations which the Commission may allege she has committed and her

right to have the advice of counsel on the matters to which this Consent Order pertains, she is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Alexander agrees to pay a fine in the amount of \$1000.00; and it is further ordered and agreed that

Respondent Alexander shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;
