WHEREAS, respondent Lam admits that he acted in violation of N.J.A.C. 11:5-4.1(a)4 and (e) by using an employment agreement that did not contain a provision that any future changes would not be binding unless agreed to by all parties; changing the compensation without the salesperson having agreed to it or initialing said changes; and failing to provide an accounting of commissions due within 30 days of termination of employment; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

RESPONDENT agrees to pay a fine in the amount of \$1500.00; and it is further ordered and agreed that

RESPONDENT shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;
