DAVID P. WOOLSEY, of full age, hereby certifies as follows:

1. I am employed by the State of New Jersey, Department of Banking and Insurance as Supervisor of the Rehabilitations and Liquidations Unit in the Office of Financial Solvency. I have held this position since 2004. My responsibilities include monitoring the operation of all insurance companies in rehabilitation or liquidation pursuant to N.J.S.A 17:30C-1 et seq. I make this certification in support of the Liquidator's application to

extend the bar date for the assertion of claims against Eagle Insurance Company in Liquidation and its subsidiaries ("Eagle") from August 9, 2008 to September 28, 2009.

- 2. On August 9, 2007, an Order of Liquidation of Eagle
 Insurance Company and its subsidiaries was entered by this
 Court. That Order provided, <u>inter alia</u>, that:
 - [A]11 claims against Eagle Insurance and its subsidiaries must be asserted no later than one year from the date of the Order of Liquidation [i.e., August 9, 2008]

A copy of the Order of Liquidation is attached as Exhibit A.

- 3. Also on August 9, 2007, the Court entered a Stay of the Order of Liquidation to allow the defendants to seek a stay of the Order of Liquidation from the Appellate Division. A copy of the Chancery Stay Order is attached as Exhibit B.
- 4. On September 10, 2007, the Appellate Division entered an Order granting Leave to Appeal and staying the Order of Liquidation. A copy of the Appellate Division Order is attached as Exhibit C.
- 5. On July 31, 2008, the Appellate Division affirmed the Order of Liquidation. A copy of the Appellate Division Opinion is attached as Exhibit D.

- 6. On August 20, 2008, the defendants/appellants filed a Petition for Certification with the Supreme Court of New Jersey. A copy of the Petition for Certification is attached as Exhibit E.
- 7. On September 28, 2008, the defendants/appellants withdrew their Petition for Certification. A copy of the letter withdrawing the Petition for Certification is attached as Exhibit F.
- 8. As a result of the filing and resolution of the appeal from the Order of Liquidation, and the subsequent filing of a Petition for Certification, the Order of Liquidation did not become final until September 28, 2008, well after the one year bar date allowed in the Order of Liquidation, which effectively established a bar date of August 9, 2008.
- 9. Due to the pending appeal and concomitant stay of the Order of Liquidation, no actions could be taken or expenses incurred with respect to the processing of claims in the estate during that time. In the event that the appeal had proved successful, any claims which might have been resolved during the pendency of the appeal would be subject to being reopened. Further, the Liquidator would also risk possible exposure to claims of misuse and waste of the assets in the estate.

10. The requested extension of the bar date will allow for the orderly processing of claims in the estate and serve to minimize the negative impact of any confusion which may have resulted from the stays entered on the Order of Liquidation. Accordingly, it is respectfully requested that an Order be entered extending the bar date for the assertion of claims against Eagle from August 9, 2008 to September 28, 2009, i.e., for a period of one year from the date that the Order of Liquidation became final.
