DIVISION OF BANKING REAL ESTATE COMMISSION Notice of Action on Petition for Rulemaking Obligations of Licensees to Public and to Each Other

N.J.A.C. 11:5-6.4

Petitioner: Nicholas Nowak.

Take notice that on March 12, 2025, the New Jersey Real Estate Commission (Commission) within the Department of Banking and Insurance, received a petition for rulemaking from petitioner, Nicholas Nowak, a licensed real estate broker-salesperson affiliated with EXP Realty, seeking deletion of the rule at N.J.A.C. 11:5-6.4(f)3, which requires that all listing agreements prepared by licensees include mandatory language pertaining to commission splits among listing and cooperating brokers. The Commission deemed the petition in substantial compliance with the requirements at N.J.A.C. 11:5-10.6 on April 8, 2025. A notice acknowledging receipt of the petition and summarizing its contents was submitted to the Office of Administrative Law for publication in the May 5, 2025, New Jersey Register.

Take further notice that on April 22, 2025, the Commission duly considered the petition pursuant to law and decided to deny the petition. The Commission notes that N.J.A.C. 11:5-6.4(f)3 does not conflict with the requirements at P.L. 2024, c. 32, therefore, deletion of the rule is not necessary at this time. Licensees may utilize alternative compensation structures and comply with both N.J.A.C. 11:5-6.4(f)3 and P.L. 2024, c. 32, by inserting "\$0", "N/A," or other appropriate notation in the required text, and, otherwise, adequately specifying the terms of broker compensation in the listing agreement. The Commission intends to promulgate more comprehensive changes to the rules to implement the purposes of P.L. 2024, c. 32 in the near future, which will substantially bear on the issues noted by the petitioner. The Commission wishes to avoid a disjointed implementation process and, accordingly, will address the matter in due course.
