# **DRBC** Update

Chad Pindar, P.E. (DRBC) provided an update on DRBC activities, upcoming advisory committee meetings, Commission actions, and other items of interest:

- The DRBC Business Meeting on December 7, 2022 resulted in the adoption of Resolution 2022-04. A
  RESOLUTION to amend the Comprehensive Plan, Water Code and Special Regulations regarding
  importations of water into and exportations of water from the Delaware River Basin and discharges
  of wastewater from high volume hydraulic fracturing ("HVHF") and HVHF related activities.

## **DRBC Storage Study Update**

The second draft of the report was transmitted back to DRBC on 12/01/2022, which was sent to the DRBC Commissioners for review and comment. Commissioner comments were received by 01/31/2023. The next steps in the project include (1) Mott McDonald / DRBC are to address the Commissioner comments, and (2) DRBC publish the final report to the website. The revised estimate of **14.2 million people** is based on 2020 U.S. Census Bureau data (whereas the previous estimate was based on data from 2016).
