Water Management Advisory Committee Meeting Highlights

Thursday, February 17, 2022 1:00 p.m. – 3:00 p.m.

Call to Order

The DRBC Water Management Advisory Committee (WMAC) was called to order by SeungAh Byun, Committee Vice Chair, and was held with remote attendance only using Zoom and its call-in capabilities.  - o Roll call was performed by Committee Liaison Michael Thompson (DRBC).

- A discussion of the methods used in this study, as well as the results of calculated availability.
- A discussion on limitations specifically related to the Coastal Plain.
