

## PROGRAM SITE

Veterans Haven South serves Veterans from all over the country looking to relocate in the Philadelphia and southern New Jersey area. Our facility is nestled in the peaceful, rural community of Winslow Township NJ.

### Things to know:

- Transportation is provided by VHS staff to Philadelphia, Camden, Sewell, Marlton and other VA referred appointments. Additionally, routine van runs are made to local Walmart, Wawa and the Avendale bus station.
- Per NJAC 8:5 Veterans with income who reside at VHS will be required to pay a maximum rent of \$300. A budget will be developed during the orientation period that includes facilitating a savings program.
- Monthly on-site visits are scheduled with Supportive Services for Veteran's Families (SSVF)

### **OUR VISION**

***The country's premiere transitional housing program aimed at solving Veteran homelessness***

### **OUR MISSION**

***Transitional Housing Program that provides a safe and stable living environment for homeless Veterans while developing a path to safe, stable and sustainable housing***

**Admissions:** Veterans must be (1) registered with the Corporal Michael Cresenz 3900 Woodland Ave Philadelphia PA., (2) complete the application/referral form (available on website), (3) provide a negative TB test taken with 6 months, and (4) complete medical certification (available on website).

Our admissions team will conduct an interview and will assist veteran in identifying transportation to our facility when necessary. Veteran must be drug and alcohol free at time of admission. **Facility:** Veterans Haven South is an 86-bed facility located in Camden County New Jersey. Veterans are assigned a single occupancy room with a twin bed,

dresser, desk, smart TV, small refrigerator, medicine cabinet, sink, and closet. The facility boasts a newly renovated day room with computers, a shared printer, TV, coffee machine, and lounge area. Veterans are provided free on-site laundry facility and a fitness room. Our dining area offers three meals per day as well as fresh fruit and bagged lunch. The dining area is equipped with a microwave, coffee machine, and ice machine. Additional recreational areas include a newly renovated pool table, Wii gaming system, outdoor gazebos, and an outdoor BBQ area with horseshoe game pits.



**Services:** Veterans Haven South offers a variety of services for Veterans enrolled in our program. During the 30-day orientation period, Veterans are assigned a Veterans Program Specialist who will assist the Veteran in obtaining their birth certificate, social security card, DD214, and a government ID. Veterans will develop an Individual Service Plan to include housing, income and health goals. Veterans will explore housing options through HUD VASH, housing authorities, VA home loan, or conventional rental

options. Veterans will explore ways to increase income through employment, vocational training, Social Security benefits and Service Connection. Veterans Haven South has a fulltime RN on staff to assist with medication refills, scheduling appointments, facilitating medical transportation, and supporting Veterans in seeking future medical resources.



### ***Specialized Services:***

Upon acceptance into our program, all veterans are assessed by our Social Worker and Licensed Substance Abuse Counselor. The outcome of these assessments will assist staff in identifying additional Veteran's needs such as Alcoholic Anonymous, Narcotic Anonymous, Smart Recovery, Gamblers Anonymous, and mental health referrals. To uphold the integrity of the program, all Veterans are subject to breathalyzers and monitored urine drug screens.
