As Commissioner Cerf indicated in his recent broadcast, we are committed to communicating with you and your colleagues on a regular basis about AchieveNJ and its implementation. This week, we are continuing to focus on the proposed components of new evaluations for 2013-14. Today, I am pleased to provide three new overview documents in addition to the other materials listed at the end of this message:

- <u>AchieveNJ Teacher Practice Overview</u>

These materials – and all of the resources posted on our new website – are intended for use by teachers, vice/assistant principals, principals, and other administrators as well as anyone seeking more information. I ask that you share these widely to help ensure that all New Jersey educators understand the new system and have opportunities to provide comments, questions, and feedback.

Yesterday, staff from the Evaluation Office had the opportunity to conduct the first of many regional presentations to share more information and hear feedback and questions directly from educators. We appreciate those who joined us in Toms River and look forward to continued dialogue with educators across the state. I encourage you to consider attending one of our eight remaining sessions (see below for registration details). Please be advised that these presentations are <u>not</u> public hearings on the proposed evaluation regulations, but rather information session intended to increase understanding about the new system. Finally, we know that many districts are seeking more support in developing measures for teachers in nontested grades and subjects. The Department is working on forms and guidance to be shared in the coming weeks; in the meantime, please see the <u>general resources</u> page on our website for examples from other states, as well as <u>previous broadcast memos</u> for examples of ways that our pilot districts have approached this work.
