#### **Meeting Called to Order**

Dr. Edwards began the meeting officially at 1:06 pm, assured the presence of a quorum, and officially called the meeting to order.

Dr. Edwards thanked all participants for joining the meeting of the Amistad Commission. Dr. Edwards read a statement pertaining to the public session of the Commission meeting to ensure compliance with the New Jersey Open Public Meetings Act. The Open Public Meetings Act was enacted to ensure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interest is discussed or acted upon in accordance with the provisions of this act. The Amistad Commission has posted notice of this meeting to be published by having the date and time in place thereof posted in the Department of Education, Secretary of State's Office. The notice was also given to the State House Press Corps and the Governor's Office.

## Pledge of Allegiance

Dr. Edwards began the meeting with the reading of the Pledge of Allegiance and asked all participants to join. "I pledge allegiance to the flag of the United States of America and to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all."

## Approval of Draft Minutes from the June 9, 2023, Commission Meeting

There was a vote to approve the minutes from the June 9th meeting of the Commission. There were eleven in favor and one abstention.

#### **Guest Speaker: Plan for Professional Development Sessions for NJ Teachers**

Dr. Amber Smith was introduced as the lead consultant for the new online professional development sessions for NJ teachers that served as the continuation of the 2023 Summer Institute. Dr. Smith presented an overview of the trainings for teachers which will cover eight sessions during the academic year.

## **Proposed Meeting Dates for Calendar Year 2024**

The meeting dates were introduced and called for a vote by the commission. The meeting dates were unanimously approved by the Commission.

## **Strategic Plan for The Commission**

Dr. Edwards reported on the significant efforts of the Strategic Planning Council to create the Commission's official draft of a Mission and Vision Statement, and a Statement of Core Values. The Strategic Planning Council also identified six strategic priorities for the Commission. The group of external supporters called the Strategic Plan Advisory Group was also officially formed and invited to a meeting next year.

## **Discussions on Ideas for the Commission Retreat**

Commissioner Bebler-Johnson reported on the scheduled Retreat of the Commission that was scheduled for October 19<sup>th</sup>. She provided a complete overview of the program and general background on the Consultant who will lead the activities for the day. A special recognition was extended to Commissioner Joshi for

hosting the event at Fairleigh Dickerson University.

## **Executive Director's Report**

The Executive provided an overview of his report which focused on the outcomes of the summer institute which was well received by teachers from across New Jersey. The Executive Director also provided updates on the Webpage and Curriculum Website which have not officially launched as result of administrative concerns that were recently addressed. The Curriculum Website was in its final stage of review and approval for launch. The office is continuing to work on the regional staffing expansion plan. These efforts will facilitate and create a strategic approach to greater outreach to New Jersey school districts.

There was a report on a plan for the Commission's first State-wide survey. The three-part survey will assess state-wide level of awareness of the Amistad Law; professional development exposure/participation in relation to the Amistad Law; and individual/school/district- based experiences with implementation of the Amistad curriculum. This intentional assessment effort is the most strategic action of the Commission to understand its impact on New Jersey over the recent years. The Commission will follow all appropriate guidelines for state-wide surveys within the Department of Education.

The Amistad Office collaboration with NJEA remains ongoing with the intention to organize a trip to Africa in August 2024. The MOA remains under review with general counsel for NJEA.

The Executive Director of the Amistad Commission also reported on the top priorities for the commission during academic year 2023-2024 which heavily focused on the launch of a new Strategic Plan for the Commission.

## Quarterly Commission Meeting – December 15, 2023

#### **Executive Director's Report**

The Amistad Office team continues to move forward with the implementation of its annual goals for the 2023-2024 academic year. The Commission remains focused on developing and launching a new strategic plan; introducing a new online professional development program for NJ teachers as a continuation of the Summer Institute; continuing conversations with a new collaboration with NJEA; developing a new state—wide assessment; and engagement of districts, students, and teacher in new Amistad initiatives.

#### **Summer Institute 2024 Overview and Plans for 2025**

Building on the success of the 2023 Summer institute, the 2024 event will follow a similar structure that identifies the needs of the teachers from grades K-5; 6-8; and 9-12. The Commission is collaborating closely with teachers throughout the state (Lesson Planning Committee) to develop the content for the 2024 Summer Institute. The 2024 Summer institute will again follow the theme for National History Day. The 2024 Summer Institute is scheduled from July 29<sup>th</sup> to August 2<sup>nd</sup> at the College of New Jersey with both in-person and remote options. The 2025 Summer Institute is tentatively scheduled from August 4<sup>th</sup> -7<sup>th</sup> at Rowan University. Two of the online professional development sessions have been held to date. The feedback has been positive from attendees. There were over 50 participants in the first two sessions.

## New Curriculum Website Launch and Plans for an RFP

The Amistad Office finalized the plans to activate the Amistad Curriculum Website. The Commission also revised the main webpage under the DOE website. The main webpage will house the link for the curriculum website. Although the content on the curriculum website remains useful for teachers as a primary resource to implement the Amistad Legislation, we find it necessary to engage in an RFP for a complete redesign of the website. Our office has already developed the content for the RFP, and we hope to begin reviewing bids in early spring 2024. The Executive Committee of the Board will have final approval on the selected agency for the redesign of the new site.

## **Status of Approved Staffing Plan**

The Board originally approved the new staffing plan for the Commission in March 2024. The office continues to work within the parameters of the DOE and the Governor's Office to determine the best strategy to move forward with posting for the new hires. The budgetary resources are available for three full-time employees that would be employees of the Commission along with three part-time Consultants/Interns. This is a new process that has taken several months to finalize. Our hope is to move forward as soon as possible.

## Status of State-Wide Assessment Survey

The State-wide survey has been designed and the Commission is currently undergoing the approval processes within the DOE to officially launch the survey. The data collection process will begin in December and end by February 1<sup>st</sup>. The Commission has also developed a dissemination plan for the data collection process to maximize the survey return/completion rate state-wide. As mentioned in prior settings, the purpose of the survey is to gather valuable information that will guide the conversations on the development of the five-year strategic plan in the months ahead. The three-part survey will assess state-wide level of awareness of the Amistad Law; professional development exposure/participation in relation to the Amistad Law; and individual/school/district- based experiences with implementation of the Amistad curriculum.

#### **MOA** with NJEA Partnership and Donation

The Amistad Office met with NJEA since the last meeting on September 22<sup>nd</sup>. We have received the revisions on the MOA from general counsel for NJEA. We are finalizing a few details before the document is review by the Attorney General Office. The Office has also developed a preliminary curriculum for teachers traveling to Africa and identified a tentative date of August 8<sup>th</sup>-20<sup>th</sup> for the event. The estimated cost per traveler is approximately \$3,200.

## **Engaging More Teachers, Students and Districts**

The Amistad Commission is in the process of creating a social studies contest on African American History in New Jersey. The goal of this committee will be to create a one-day contest, specifically, for grades (fourth and fifth) that will highlight the accomplishments of African Americans in New Jersey's local History. This program is designed to prepare students to participate in the National History Day Contest and promote the Amistad Commission's mission. Students will be asked to submit projects in the following categories: exhibit, website, documentary, performance, and paper. We are currently looking at two locations (North and South) Jersey, in the late spring of 2024. This is part of the Commission's new student engagement initiatives as defined in one of the six strategic priorities noted in the new strategic plan.

The Amistad Lesson Plan Committee. The goals of the *Amistad Commission Lesson Plan Review Committee* are to screen and select model lessons from educators in New Jersey, so that the staff can make these lessons available through the Amistad Website. The committee will be responsible for selecting the Amistad Commission's Special Award for National History Day winners. The committee members will be responsible for participating in the design of the Amistad Commission's Summer Curriculum Institute. Committee members will be asked to assist staff in Amistad Professional Development Trainings. We currently have 24 Lesson Plan Committee members, from eighteen of the twenty-one counties in New Jersey. These members play a critical role in providing the office staff with real-time information about what is happening in classrooms throughout New Jersey. They are also key to providing other educators with information about the Amistad Commission and the commission's goals and mission. The group will also serve as advisors on the Commission's new strategic plan.

## **Moving Forward**

The Amistad Office team continues to address both challenges and opportunities to successfully meet the mandate of the Amistad Legislation. This is our moment to truly impact the lives of students, teachers, and educators from the great state of New Jersey. Through the support of our Board of Commissioners, our partners within the DOE, and the Governor's Office, we can accomplish the intent and purpose of the Amistad Legislation.
