## Office of Career Readiness Announces Career Clusters<sup>®</sup> Available for CTE Program Reapproval

The New Jersey Department of Education's (NJDOE) Office of Career Readiness is scheduled to commence reapproval of Career and Technical Education (CTE) programs in the following Career Clusters:

- Finance;
- Government and Public Administration;
- Human Services (Cosmetology only);
- Information Technology;
- Law, Corrections, Public Safety and Security; and
- Science, Technology, Engineering & Mathematics (STEM).

School districts with these approved CTE programs must submit their reapproval application(s) via the <u>CTE Data</u> <u>Management System (CTE-DMS)</u> located in the NJDOE Homeroom web portal. The reapproval period will open on May 21, 2021 and will close on November 30, 2021.

To ensure CTE programs are rigorous, reflect current industry standards, and adhere to the quality measures set forth in the <u>New Jersey Perkins V State Plan</u>, the NJDOE requires all programs to be reapproved in accordance with *N.J.A.C.* 6A:19-3. A listing of all approved CTE programs can be found on the <u>Office of Career Readiness</u> webpage.

To assist district representatives with the reapproval process, the Office of Career Readiness is offering virtual technical assistance workshops.
