# **Title I Targeted Assistance Schools – Process to Transition to Schoolwide Programs**

Under the *Elementary and Secondary Education Act (ESEA)*, as reauthorized by the *Every Student Succeeds Act (ESSA)*, the Title I, Part A Program is designed to help economically disadvantaged students meet high academic standards by participating in either a *schoolwide* or a *targeted assistance* program. *Targeted Assistance* programs use Title I, Part A funds to support programs for identified students with the highest academic need only (i.e., students failing or most at risk of failing) in order to meet the district's core academic curriculum. *Schoolwide* programs are implemented in high-poverty schools using Title I, Part A funds to upgrade the entire educational program in addition to supporting a program that provides services for identified students with the highest academic need.

Title I-funded schools currently operating *targeted* assistance programs have the option to transition to Title I *schoolwide* programs. Transitioning to a Title I *schoolwide* program allows a district to:

- Serve all students A school operating *a schoolwide* program does not need to identify particular students as eligible to participate (ESEA section 1114(a)(2)(A)(i));
- Provide services that need not be supplemental A school operating a schoolwide program does not need
  to provide specific services that supplement the services participating students would otherwise receive
  (ESEA section 1114(a)(2)(A)(ii)); and
- Consolidate Federal, State, and local funds A school operating a schoolwide program may consolidate
  Federal, State, and local funds to better address the needs of students in the school (ESEA section
  1114(a)(1)(A)).

### **Background**

The following Title I-funded targeted assistance schools may elect to transition to a Title I schoolwide program for the 2021-2022 school year:

- Title I targeted assistance schools with less than 40-percent of its students living in poverty that receive an approved waiver for the 40-percent poverty requirement from the New Jersey Department of Education (NJDOE); and
- Title I targeted assistance schools that meet the 40-percent poverty requirement.

In accordance with <u>ESEA</u> section 1114, a school operating a Title I targeted assistance program (section 1115) that elects to transition to a Title I schoolwide program must:

- Conduct at least one year of planning for a transition to a schoolwide program, which may be waived if the school previously has been operating under a strategic plan or improvement plan that addresses the entire school;
- Consult with all relevant school stakeholder groups; and

- Submit an Annual School Plan (ASP) to the NJDOE via Homeroom that addresses the following required components:
  - 1. A Comprehensive Needs Assessment of the entire school;
  - 2. Strategies to address school needs, including a description of how such strategies will:
    - a. Provide opportunities for all children, including each subgroup of students, as defined in *ESEA* §1111(c)(2), to meet the challenging state academic standards;
    - b. Use methods and instructional strategies that strengthen the academic program in the school, increase the amount and quality of learning time, and help provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education; and
    - Address the needs of all children in the school, but particularly the needs of lowachieving students who are at risk of not meeting the challenging state academic standards, through various support activities; and
  - 3. An annual evaluation of the implemented programs and services as articulated in the ASP.

## **Schoolwide Poverty Percentage Waiver Request**

At this time, the NJDOE is providing an opportunity for interested Title I targeted assistance schools with less than 40-percent poverty to apply for waivers. NJDOE approval of the waiver is necessary for Title I targeted assistance schools with less than 40-percent poverty to apply for Title I schoolwide status for the 2021-2022 school year.

Schools with less than 40-percent poverty rates that are interested in transitioning to a Title I schoolwide program for the 2021-2022 school year, must submit a Title I schoolwide waiver request application using the template on the NJDOE's <u>Title I webpage</u>. The waiver request application must be submitted no later than **Friday, January 29, 2021** via email to <u>schoolwide@doe.nj.gov</u>.

The NJDOE will issue official notifications to schools upon approval of the poverty percentage waiver requests, with specific instructions on the next steps in the transition process to schoolwide programs.

## **Schoolwide Program Guidance**

To assist schools with the schoolwide transition process, the Office of Supplemental Educational Programs has created a "Title I Schoolwide Transition Process" document available on the NJDOE's <a href="Schoolwide Programs">Schoolwide Programs</a> webpage.

Additional details on Title I schoolwide programs are provided in the <u>Supporting School Reform by Leveraging Federal Funds in a Schoolwide Program</u> guidance document from the U.S. Department of Education. This guidance highlights advantages and flexibilities inherent in a Title I schoolwide program.
