New Jersey Learning Acceleration Program: High-Impact Tutoring Notice of Grant Opportunity (NGO) Reissue

The New Jersey Department of Education (NJDOE) is excited to announce the reissue of the New Jersey Acceleration Program: High-Impact Tutoring NGO. This limited competitive grant initiative provides approximately \$10,500,000 in funding to Local Education Agencies (LEAs) to offer high-impact tutoring interventions for students disproportionately affected by the pandemic. This program will begin on March 20, 2024, and will close on December 31, 2024. It is open to all operating New Jersey public school districts serving students in grades three (3) and/or grade 4 (four) that did not receive funding in the initial issuance of the grant program in the Fall of 2023, or did not apply for the initial opportunity.

Eligible LEAs may apply for up to \$768,000 in grant funds based on a tiered student enrollment system correlated with maximum funding levels. This opportunity prioritizes offering High-Impact Tutoring to students in grades three (3) and four (4) but will allow LEAs to serve additional students as needed. LEAs may deliver tutoring services by contracting with a tutoring vendor or by compensating existing LEA staff for their tutoring services.

The New Jersey Learning Acceleration Program: High-Impact Tutoring Reissue NGO is now available on the Office of Grants Management [webpage](#), under the [2024 NGOs](#) Grant Opportunities section. Grant applications will be completed using the Electronic Web-Enabled Grants ([EWEG](#)) System accessed through the NJDOE's Homeroom web portal. The grant application must be submitted by 4 p.m. on Wednesday, January 31.
