Anti-Bullying Task Force Announces Dates for Public Testimony

New Jersey's Anti-Bullying Task Force (ABTF) will host two public hearings, one in-person and one virtual session, to provide families, students, and other stakeholders an opportunity to share experiences regarding the implementation of the *Anti-Bullying Bill of Rights Act* in New Jersey schools.

Hearing from individuals who have been affected by New Jersey's anti-bullying law will greatly inform the work of the task force who is charged with examining its impact and making recommendations for improving the way that harassment, intimidation, and bullying is addressed in schools. Insight gained from the sessions may be incorporated into the ABTF's upcoming report.
