School District Consultations with Nonpublic Schools Regarding ESSA Titled Programs

This memo serves as a reminder to public school districts of the requirement of the *Elementary and Secondary Education Act of 1965*, as amended by the *Every Student Succeeds Act* (ESSA), to provide consultation for equitable services for nonpublic school students, their teachers, and other educational personnel.

Consultation must begin before the implementation of services. The New Jersey Department of Education (NJDOE) advises school districts to begin the ESSA consultation process as soon as possible to ensure that all third-party contracts and agreements are executed no later than June 30, 2024, so services can begin on July 1, 2024.

Consultation establishes positive and productive working relationships and is essential to effective planning. Consultation should continue throughout implementation of equitable services to ensure that the services meet the needs of eligible students, their teachers, and other educational personnel.

ESSA Equitable Services Webinar

On April 16th, the U.S. Department of Education will be hosting a free webinar, <u>Equitable Services for Eligible Private School Children</u>, <u>Teachers</u>, <u>and Other Educational Personnel</u>. This webinar will provide an overview of the equitable services requirements under Title I and Title VIII, Part F of the ESEA. It is strongly encouraged that all interested district personnel register for this free event.
