Portfolio Appeals Process – Information and Updates for 2024-2025 Submissions

The New Jersey Department of Education (NJDOE) portfolio appeals process will continue to support a fully electronic submission process for the 2024-2025 school year. Local educational agencies (LEAs) and approved private schools for students with disabilities (APSSDs) may begin submitting portfolio appeals through the electronic submission process beginning **December 11, 2024**.

To fulfill the assessment component of the New Jersey high school graduation requirements, a student must demonstrate proficiency in both English language arts (ELA) and mathematics. Any eligible grade 12 student in the class of 2025, including students with disabilities and multilingual learners, who has taken the New Jersey Graduation Proficiency Assessment (NJGPA) may do this via three pathways as explained in the Classes of 2023-2025 High School Graduation Assessment Requirements webpage.

The portfolio appeals process provides an opportunity for students in the class of 2025 to meet the graduation assessment requirement. This memo explains the 2024-2025 portfolio appeals process, which is to be completed in accordance with *N.J.S.A.* 18A:7C-3 and *N.J.A.C.* 6A:8-5.1, for students scheduled to graduate in spring 2025 who have taken the New Jersey Graduation Proficiency Assessment (NJGPA) and not yet met the state graduation assessment requirement for ELA and/or mathematics.

Portfolio Appeals Updates and Timelines Updates for the 2024-2025 School Year

The following updates were made for the 2024-2025 school year:

- The submission window has been expanded to enable submission beginning on December 11, 2024.
- Students with qualifying ASVAB composite scores may use the new streamlined portfolio appeal option. Additional information about this option is shared in a separate broadcast.
- Each school submitting a portfolio appeal must have their own Statement of Assurance (SOA) and their own Portfolio Appeals Data Spreadsheet. LEAs and APSSDs may not combine multiple schools' information on the same spreadsheet.
- LEAs and APSSDs must list the correct accountable district and school codes in the Portfolio Appeals Data Spreadsheet. The school code on the SOA, which may be different from the accountable district and school code, will be used to generate portfolio appeal decision letters.
- A Frequently Asked Questions (FAQs) section has been added to the <u>Graduation Assessment Requirement</u> webpage under the section Third Pathway—Graduation Portfolio Appeal.

Portfolio Appeals Timeline

The portfolio appeal must be submitted in accordance with the following timelines:

• The portfolio submission process begins on **December 11, 2024**. LEAs may begin submitting the required documentation through NJDOE Homeroom on this date.

- All portfolio appeals must be submitted by May 2, 2025, to ensure decision letters can be sent in advance
 of June graduation ceremonies.
- LEAs will be notified of NJDOE decisions regarding their portfolio appeals through NJDOE Homeroom on an ongoing basis.
- Appeals submitted after May 2, 2025, will still be reviewed; however, the NJDOE cannot guarantee that
 decisions will be communicated to the LEA in time for the student to participate in spring 2025 graduation
 ceremonies.
- Submissions for class of 2025 summer graduates will be accepted until **August 28, 2025**.
- LEAs and APSSDs participating in the Seal of Biliteracy program are strongly encouraged to submit
 portfolio appeals for eligible students as early as possible to facilitate timely verification of English
 language proficiency.

Portfolio Appeals Procedures

Electronic Submission Process

For the 2024-2025 school year, the NJDOE will be accepting portfolio appeals submissions electronically beginning **December 11, 2024**. The NJDOE will accept submissions **only** through this electronic submission process; paper submissions will not be accepted. In preparation for the electronic submission, each LEA and APSSD shall designate an individual to serve as the portfolio appeals coordinator. This person must be assigned to the Portfolio Appeals project in NJDOE Homeroom, which will be available beginning on **December 11, 2024**. Within the Portfolio Appeals application in NJDOE Homeroom, the portfolio appeals coordinator will find the templates that will need to be completed and submitted along with resources that will facilitate successful submission of files in NJDOE Homeroom.

The following templates are available in NJDOE Homeroom and will need to be completed and uploaded to NJDOE Homeroom by LEAs and APSSDs that are submitting portfolio appeals for students in the class of 2025:

- Statement of Assurance (SOA) for Portfolio Appeals
 - o Outlines the portfolio appeals requirements and expectations.
 - Requires the signatures of the portfolio appeals coordinator, high school principal, and chief school administrator to verify that the portfolio appeals process has been completed with integrity in accordance with N.J.S.A. 18A:7C-3 and N.J.A.C. 6A:8-5.1.
 - o A separate SOA must be completed for each school within the LEA.
- Portfolio Appeals Data Spreadsheet
 - o Provides LEAs and APSSDs with a standardized submission template and includes a variety of commonly used, required fields (e.g., Accountable District Code, State Student Identifier).
 - Includes ELA and mathematics specific fields for LEAs and APSSDs to submit students' scores on Constructed Response Tasks (CRTs).
 - A separate spreadsheet must be completed for each school within the LEA or APSSD.

Locally Maintained Portfolio Appeals Documents

LEAs are expected to store students' completed portfolio appeals materials onsite in accordance with local document retention policies. A review of these documents may occur at the discretion of the NJDOE. Below is a list of the materials that must be maintained locally for each student:

- A completed Education Proficiency Plan (EPP) that includes the most current student transcript, documentation of performance on each component of the required New Jersey Graduation Proficiency Assessment (NJGPA) and any substitute competency assessments that may have been attempted, and an intervention plan implemented to ensure the student met the graduation assessment requirement.
- CRTs in the content areas (ELA and/or mathematics) in which the student has not met the graduation assessment requirement.
- The required quantity of a student's graded responses to CRTs in each content area.
- A content-specific cover sheet for ELA and/or mathematics.

Reminder: CRT Requirements

Requirements for the CRTs in ELA and Mathematics

The CRTs are designed, administered, and graded locally. The CRTs must be designed to demonstrate that the student has core ELA and mathematical competencies equivalent to the expectations of the New Jersey Student Learning Assessments (NJSLA) and the NJGPA Evidence Statements, which are available on the New Jersey Assessments Resource Center under Educator Resources > Test Content and Other Information. Please note that LEAs and APSSDs may use their existing CRTs for ELA and/or mathematics in the 2025 portfolio appeals process. If an LEA or APSSD chooses not to use existing CRTs, the LEA or APSSD may use revised, refreshed, or newly created CRTs for the 2025 portfolio appeals process if the revised, refreshed, or newly created CRTs demonstrate that the student holds core competencies equivalent to the following:

- For ELA CRTs: The expectations of the NJSLA/NJGPA ELA Reading and Writing Evidence Statements for high school.
- For Mathematics CRTs: The expectations of the NJSLA/NJGPA Mathematics Reasoning (C) or Modeling (D) Evidence Statements for Algebra I, Geometry, and/or Algebra II.

ELA

Supporting Special Populations

Students in special populations, such as multilingual learners and students with disabilities, are expected to participate in the portfolio appeals process and receive appropriate accommodations.

LEAs and APSSDs should, as appropriate and in accordance with the student's IEP, encourage students with disabilities to participate in the portfolio appeals process if they have not yet met the graduation assessment requirement for ELA and/or mathematics.

For multilingual learners, LEAs and APSSDs may translate CRTs into a student's native language and the student may respond in their native language. The portfolio appeals process also allows for the use of electronic translators. The student's responses and the CRTs must be translated or transcribed into English upon completion. The original student work and the translated or transcribed version must be retained with all other locally retained portfolio appeals documents.
