Advanced Placement (AP) and International Baccalaureate (IB) Course Expansion and Establishing Advanced Placement African American Studies Notice of Grant Opportunities (NGO)

The New Jersey Department of Education (NJDOE) is excited to announce the release of two notices of grant opportunities designed to assist local educational agencies (LEAs) in expanding Advanced Placement (AP) and/or International Baccalaureate (IB) offerings:

- 1. The <u>Advanced Placement (AP) and International Baccalaureate (IB) Course Expansion</u> NGO provides LEAs with the opportunity to offer formal training to teachers to expand the number of educators teaching AP or IB classes, expand the number of AP or IB courses offered, or expand equitable access to college-level AP/IB courses particularly for underrepresented student groups.
 - a. This grant is open to all operating New Jersey public LEAs with at least one school that qualifies for the federal definition of a schoolwide Title One program. To meet the definition, a school must have at least 40% of its student population identified as low-income households.
- 2. The <u>Establishing Advanced Placement African American Studies NGO</u> will provide funding to LEAs for the opportunity to onboard and offer Advanced Placement African American Studies (AP AAS) to students starting in the Fall of 2024.
 - a. The AP AAS NGO is open to all LEAs serving students in grades nine (9) through twelve (12) with the intention to open a section, or an additional section of AP AAS in the 2024-2025 school year. Eligible LEAs also include those that are currently participating in the 2022-2023 AP AAS pilot program.
- Both grant programs are scheduled to begin on April 1, 2024, and will close on December 31, 2024.
- Grant applications must be submitted by 4:00 p.m. on Tuesday, February 13, 2024.
