**Proposal Level Code – N.J.A.C. 6A:23A, Fiscal Accountability, Efficiency,
and Budgeting Procedures**

At its March 6, 2024, public meeting, the New Jersey State Board of Education (State Board) approved the following rulemaking for publication in the May 6, 2024, *New Jersey Register*. The proposal, which can be viewed on the New Jersey Department of Education's (NJDOE) [Administrative Code webpage](#), includes:

- Readoption with amendments of Subchapters 16 through 22 at N.J.A.C. 6A:23A, Fiscal Accountability, Efficiency, and Budgeting Procedures, which set forth rules for fiscal accountability, financial accounting and recordkeeping, calculation of tuition for public schools and approved private schools for students with disabilities (APSSDs), residency determination, and the financial operations of charter schools.

The State Board values public input in all matters regarding code promulgation. [Public testimony](#) on the re-adoption with amendments of Subchapters 16 through 22 at N.J.A.C. 6A:23A is scheduled to be held on June 5, 2024. Registration for public testimony will open on May 16, 2024, and close at noon on May 30, 2024.

Acting Commissioner of Education Kevin Dehmer also approved the proposal below for publication in the May 6, 2024, *New Jersey Register*. The proposal, which can be viewed on the NJDOE's [Administrative Code webpage](#), includes:

- Re-adoption with amendments of Subchapters 1 through 15 at N.J.A.C. 6A:23A, which set forth rules for fiscal accountability, efficiency, and budgeting procedures, transfers and reserve accounts for public schools, and State aid calculations and aid adjustments for charter schools.
