## School District Consultation with Nonpublic Schools Regarding State-Funded Programs

School districts that have nonpublic schools located within district boundaries are responsible for ensuring the on-time delivery of State-funded programs and services to nonpublic school students. In the coming weeks, school districts need to hold *timely and meaningful consultation meetings* with respective nonpublic schools to ensure that Fiscal Year 2026 programs and services meet the needs of the nonpublic schools.

### Consultation Process & Timing

The New Jersey Department of Education (NJDOE) encourages districts to send the [nonpublic school consultation form](#), with information pre-populated by the school district where able, to the nonpublic schools *in advance of consultation*. The nonpublic school representative(s) are encouraged to attend the consultation with all applicable fields completed in order to make decisions on how the nonpublic school would like funds to be spent. Consultations may be conducted virtually, electronic signatures are acceptable, and all signed forms may be collected via email.

The NJDOE recommends that any school district contemplating a change in nonpublic service provider hold consultations by late April. If there are no anticipated changes to the provision of services, consultations should be held by the end of May.

### Health and Safety Requirements of Nonpublic School Facilities: Attestation and Guidance

To help ensure the health and safety of New Jersey's nonpublic school students and staff, the NJDOE requires that all nonpublic schools registered with the NJDOE comply with the health and safety facilities laws and regulations. The NJDOE requires that school districts collect the signed [Attestation of Compliance with Health and Safety Requirements of Nonpublic School Facilities](#) from registered nonpublic schools at the spring consultations.
