NJDOE Seeks Input on New Jersey Student Learning Standards (NJSLS) for Comprehensive Health and Physical Education (CHPE) and Social Studies (SS)

Pursuant to N.J.A.C. § 6A:8-2.1 the New Jersey Department of Education (NJDOE) is required to review 2020 New Jersey Student Learning Standards for Comprehensive Health and Physical Education (CHPE) and Social Studies (SS). The NJDOE is committed to engaging stakeholders in collaborative efforts to ensure the standards are rigorous, research-based and appropriate to prepare students to be college- and career-ready.

To conduct this comprehensive review, the Division of Teaching and Learning Services seeks to establish a highly qualified and diverse committee of volunteers with broad stakeholder representation. A self-nomination process will be used to identify educators, content experts, and other qualified stakeholders to serve on one of two committees convened as part of the standards review process, based on candidate qualifications and experience.

This is a second call for input for participation on the implementation and college- and career-readiness committees.

Committee Eligibility and Dates

The details regarding the Comprehensive Health and Physical Education and Social Studies implementation and college- and career-readiness committees, the required qualifications, and mandatory time commitments are as follows:

Implementation Committee

Virtual meeting times will be determined based on surveys of the participants. The Implementation Committee will include up to 40 educators. The NJDOE seeks committee members to participate in meetings scheduled as follows:

- **Comprehensive Health and Physical Education (CHPE):** Practicing appropriately certified educators with at least five years of experience in teaching comprehensive health and physical education in K-12 in New Jersey public schools; and instructional leaders with at least five years of experience in leading the implementation of the New Jersey Student Learning Standards for Comprehensive Health and Physical Education and who possess teaching experience in the content area.

- **Social Studies (SS):** Practicing appropriately certified educators with at least five years of experience in teaching social studies in K-12 in New Jersey public schools; and instructional leaders with at least five years of experience in leading the implementation of the New Jersey Student Learning Standards for Social Studies and who possess teaching experience in the content area.

In addition, asynchronous assignments approximating a total of 10 hours of work will be assigned as needed.

College- and Career-Readiness Committee (CCR)

Virtual meeting times will be determined based on surveys of the participants. The College and Career Readiness Committee for each content area will include **up to 40 members** from local school boards, higher education faculty, community groups, parents and students, and business and industry. Well-qualified candidates will have extensive knowledge of post-secondary outcomes for students. School counselors and career coaches may apply.

Applicants actively employed by a Local Education Agency (LEA), must obtain Chief School Administrator (CSA) approval by asking their CSA to complete the CSA Attestation Form linked below by **June 30, 2026**. LEA employees will not be able to participate without CSA attestation.
