## **Legal Committee Report**

The Legal Committee reviewed all legal cases and presented its recommendations to the Board.

Dr. Knowlton announced that the matter of Patrick Aiello would be removed from the agenda and transmitted to the Commissioner to hear as an appeal of the Board's prior decision.

The Board took the following actions:

<u>Thomas Carney</u> – The Board unanimously voted to issue an Order to Show Cause to him based on the level and nature of his conduct.

<u>Cesar Escurra</u> – The Board unanimously voted to issue an Order to Show Cause to him based on the level and nature of his conduct.

<u>Manuel Ferreira</u> – Dr. Knowlton recused himself from the case. The Board unanimously voted to issue an Order to Show Cause to him based on the level and nature of his conduct.

<u>Kelly Gibbons</u> – The Board unanimously voted to issue an Order to Show Cause to her based on the level and nature of her conduct.

<u>Leon Grove</u> – The Board unanimously voted to table the matter in order to obtain further information.

<u>Anna Humphrey</u> – The Board unanimously voted to take no action against her teaching certificates.

<u>Virginia Rachko</u> – The Board unanimously voted to issue an Order to Show Cause to her based on the level and nature of her conduct.

<u>David St. John</u> – The Board unanimously voted to take no action against his teaching certificates.

<u>Joshua Fava</u> – The Board unanimously voted to take no action to block his application for certification.

<u>Allison Heater</u> – The Board unanimously voted to take no action to block her application for certification.

<u>Karen Gaba</u> – The Board unanimously voted to approve her application for an opportunity to apply for certification after revocation because she has shown rehabilitation from the conduct that was the basis for the revocation.

<u>Ruth Munoz</u> – The Board voted to adopt the recommendation of the Administrative Law Judge in the Initial Decision that the Board accept the proposed settlement changing her "disapproved" rating to "insufficient." Mr. Tirri abstained from the vote.

DAG Walters reviewed the recent State Board of Education decisions regarding the authority of the State Board of Examiners to review and revoke county substitute certificates. The Board then had a discussion regarding the need for the Department of Education to handle cases concerning county substitute certificates in a timely manner.

Dr. Knowlton made a motion to send a resolution to the State Board of Education expressing the concern of the State Board of Examiners regarding the county substitute situation, with a copy of the resolution sent to the county superintendents of schools. Mr. Tirri seconded the motion and it was passed by a unanimous vote.
