#### **Legal Committee Report**

The Legal Committee reviewed all legal cases and presented its recommendations to the Board. The Board took the following actions:

Dr. Purnell made a motion to go into closed session in order to receive legal advice regarding settlement proposals, which was duly seconded by Ms. Gales and carried by a unanimous vote. The Board went into closed session at 12:15 p.m. The Board returned to the public session at 1:30 p.m.

Sandra Santora – By a vote of 6 to 0, the Board voted to deny the request for oral argument made by counsel for Ms. Santora and to adopt the findings of the Administrative Law Judge and take no action against her certificates.

Brian Ammon – By a vote of 6 to 0, the Board voted to revoke his certificate based on the level and nature of the conduct.

Joseph Winkelried – By a vote of 6 to 0, the Board voted to revoke his certificates based on the level and nature of the conduct and crime.

Brian P. Corcoran – By a vote of 6 to 0, the Board voted to revoke his certificates based on the level and nature of the conduct and the surrender and revocation of his certificates in other states.

Joseph A. Greco – By a vote of 6 to 0, the Board voted to suspend his certificates pending disposition of criminal charges.

Eugenio Morales – By a vote of 6 to 0, the Board voted to revoke his certificates based on the level and nature of the conduct and crime and his disqualification from employment in the public schools.
