Dear Charter School Leaders and Representatives,

As your school gears up to recruit new students for next school year, I want to take this opportunity to remind you about charter school admissions and enrollment best practices. As you are aware, charter schools are free, open-enrollment schools that, just like traditional public schools, are required by law to serve all students. Per *N.J.S.A.* 18A:36-7, charter schools must be open to all students on a space- available basis and must not discriminate in their admission policies or practices.

With this in mind, the charter school admission process must be open to students requiring special education services, students who are English Language Learners, students who qualify for free or reduced-price lunch, and other underserved or at-risk populations. It is imperative that charter schools clearly communicate that high-need students are welcome at their schools.

The revised <u>Organizational Performance Framework</u> places a strong emphasis on access and equity for New Jersey charter schools. Upon receipt of the school's annual report, the Department examines whether a school's recruitment, admissions and enrollment processes are fair and equitable. Furthermore, the Department collects data and information to determine whether the school is minimizing attrition rates and maintaining enrollment stability.

The Department also released "<u>Guidelines for Access and Equity in New Jersey Charter Schools</u>" to remind schools of the legal requirements and national best practices with regard to recruitment, admissions, lottery and enrollment in charter schools. We ask that all charter schools thoroughly review these guidelines and reach out to the Office of Charter Schools with any questions.

The Office of Charter Schools is currently reviewing information on each charter school's recruitment, application, admissions, lottery and enrollment policies and practices to ensure that charter schools in New Jersey are open to all students. Schools should expect additional communication regarding this review in December.

Thank you and we look forward to continuing our partnership to improve outcomes for all New Jersey students.

PARCC Results

On October 20, 2015, the Department presented <u>statewide results</u> from the 2015 administration of the PARCC assessments. Districts and charters can expect to have access to their student-, school- and district-level data beginning in mid-November. Student score reports will also begin to be mailed in mid-November to districts and charters for dissemination directly to families.
