Notice of Rule Waiver/Modification/Suspension Pursuant to Executive Order No. 103 (2020)

**COVID-19 State of Emergency**

This is an emergency adoption of temporary modifications to rules governing the

operation of school districts pursuant to N.J.A.C. 6A:32-7.1 and 7.5. Section 6 of EO 103 and

Section 1 of EO 117, issued in response to the COVID-19 pandemic, authorize agency heads to

waive/suspend/modify any existing rule, where the enforcement of the rule would be detrimental

to the public welfare during the emergency, notwithstanding the provisions of the Administrative

Procedure Act or any law to the contrary. Pursuant to that authority, and with the approval of the

Governor and in consultation with the State Director of Emergency Management and the

Commissioner of the Department of Health, the Commissioner of Education is modifying Department of Education rules as follows:

Current Department regulations at N.J.A.C. 6A:32-7.1 and 7.5 require district boards of education to provide access to student records to "all authorized organizations, agencies, and persons defined" (authorized persons) within 10 days of a request. Pursuant to N.J.A.C. 6A:32-7.1(b), a student record, by definition, is "maintained within the school district."

In light of the extended public health-related school closures, authorized persons cannot access student records by reviewing the records in person within the school district. Therefore, school district staff must make student records otherwise available for review. In these unprecedented times, school districts must direct their limited resources of time and talent toward the most pressing needs of their students. Thus, the ability of district boards of education to reproduce student records for disclosure or to send to another school district if a student has transferred within the requisite 10 day time period may prove overly burdensome. Therefore, requiring school districts to provide student records within 10 days of a request would be burdensome during the public health-related school closures.

Under the modified rules, district boards of education will be required to make a "reasonable effort" to provide student records in response to requests from authorized persons within 10 days; however, the language guaranteeing the production of the student records within this timeframe will be removed. These modifications are consistent with P.L. 2020, c. 10, which applies to school districts, and the modifications to a state agency's deadline to respond to a request for a government record under the Open Public Records Act, N.J.S.A. 47:1A-1, et seq., during a public health emergency.

**Full text** of the proposed modifications follows (additions indicated in boldface **thus**; deletions indicated in brackets [thus]):

## Subchapter 7. Student Records

6A:32-7.1 General considerations
