Summary of Public Comments and Agency Responses:

- 1. Comment: The commenter expressed support for the proposed update to the standards for professional learning at N.J.A.C. 6A:9C-3.3(a)1, 2, and 3 and the standard's alignment to the model Learning Forward standards. (1)
- 2. Comment: The commenter requested that the Department revisit the <u>list of mandatory</u> trainings for staff due to the amount of time, energy, and expense that school districts must dedicate to satisfy the requirements each year. (2)

Response: The Department thanks the commenter for the support.

- Response: The Department thanks the commenter for the suggestion. However, the professional development requirements listed on the Department's website and updated in 2020, go beyond the core requirements for professional development planning and implementation set forth at N.J.A.C. 6A:9C. The professional development list originates from the numerous State statutes identified in the list of mandatory trainings, and the Department does not have the authority to modify the requirements.
- 3. Comment: The commenter requested that the Department revisit AchieveNJ and other professional development requirements and streamline them into a common-sense process that removes redundancies. (3)

Response: The Department disagrees that there are redundancies in the professional development requirements at N.J.A.C. 6A:9C and the commenters did not provide examples to adequately respond. The comment about AchieveNJ is outside the scope of this rulemaking because N.J.A.C. 6A:10 sets forth the rules related to educator evaluation.

The rules readopted with amendments and new rules will further align New Jersey's regulations with Federal requirements under the Every Student Succeeds Act (P.L. 114-95) and ensure New Jersey's public school system prepares students for postsecondary education and the 21st century workplace.
