# **Call to Order and Greeting**

# Review of March 22, 2024, ACFFP Meeting Highlights

The March 22, 2024, meeting notes were sent out in advance electronically for members to review. Dr. Wright asked the assembled body if there were any questions, comments, or concerns. Seeing no comments in the Chat Box, Dr. Wright requested the meeting notes be entered into the records as accepted by the body. Once again, we would like to acknowledge advanced feedback received from Ms. Wanda Knox.

## **Federal Update**

Ms. Aida Epifanio, Federal Liaison Office of Strategic Operations

Ms. Epifanio began by informing the assembled body that in late March, Congress reached a funding deal for the U.S. Department of Education (USED) for the remainder of FY23-24.

USED will receive \$79.1 billion for the FY that lasts through September 30<sup>th</sup>, which includes a cut of about \$100 million to the USED's budget even as it provides a small increase to key K-12 programs, including increases of \$20 million each to Title I grants and IDEA.

On April 19, 2024, the USED released updated Title IV regulation that strengthen protections against sex discrimination in federally funded education programs. The new regulations include a new definition of sexual harassment and new procedures for investigating Title IV violations.

#### **ESSA State Plan Revision Project and Key Proposals**

Mr. Azan Waddell started the group presentation with an overview of the state plan review process by emphasizing the process is grounded in the 1965 law...that all students will receive a high-quality education. As a result of the ground lost in the past few years due to COVID it is imperative that we accelerate and focus on closing educational achievement gaps.

Ms. Jessica Merville continued the dialogue by presenting an insight into the development process the working groups utilized. The working groups were comprised of diverse internal stakeholders from more than sixteen offices across the Department who were led by Working Group Leaders who spearheaded the process. Holistic discussions and focused conversations were held by all groups as they reviewed their respective sections to produce innovative research-based proposals to move the Department's work forward.

The external stakeholder group included representation from more than forty statewide organizations that support and advocate for educators and students on a wide array of topics. Five sessions were held from January to March to facilitate rich discussions and feedback on potential enhancements to the NJ School Accountability Systems.

Ms. Leslie Franks-McRae assisted by Ms. Lori Ramella presented *Key Proposals: Additional Improvements and Research*. They invited those assembled to become more verbal in order to let the groups hear more from all of you about their wish list items, related to the state plan. It was pointed out that the state plan contains multiple sections. The focus of the part of the group presentation was on Title I, Part C: Education of Migratory Children; Title III, Part A, Subpart 1: English Language Acquisition and Language Enhancement; and Homeless Children and Youth.: McKinney-Vento Homeless Assistant Act, Title VII, Subtitle B. ## Title I, Part D, Subsection 2

Ms. Stromberg focused her presentation on the Middlesex County Youth Detention Center (YDC)where Title I, Part D funds are utilized to facilitate a curriculum entitled "The Master Plan." She then presented a six-minute video featuring the founder and author of the Master Plan. The program is a 15-week program with two facilitators (one who has experienced incarceration and one certified through the Chris Wilson Foundation). As a result of this program the Middlesex County YDC has reported an improvement in student grades, class participation, and completion and quality of classwork.
