Shared by Maurita Bivans, Ed.D., ACFFP Member: "An Athletic Experience That Gives Back"

The activity: the Annual Invitational United Track Meet

Recently, this athletic event took place at Glassboro High School in South Jersey; by definition, a United Track Meet includes both non-disabled and students with disabilities. This event demonstrated how much can be gained by both student groups as well as all those connected with the planning and implementation process. On this day, four schools were invited to the event; a few weeks ago, at the Delsea Regional School, a similar event was held with fifteen schools participating. The event looked like a reduced version of the Penn Relays.

What was so impressive was the presence of a sizable number of the non-disabled students and the role they played in the success of the event. The general education students were peer guides as they ran with student long jumpers and those competing on the track. They ran alongside or behind the competitor, shouting their names, affirmations for encouragement and execution signals. The high school cheerleaders were present in uniform, moving from the track to the field events cheering on the competitors; the PA announcer gave the name of each competitor prior to the starting "whistle" being blown. Fun music played throughout the event that was officiated by NJSIAA Officials. The action around the track looked like a reduced version of the Penn Relays.

The general education students who worked with their peers were not participating in an event for the first time. It was evident that these students had developed relationships with their peers over time during previous meets, had an understanding of their disabilities/limitations and had learned what they needed to be successful. These strong peer to peer relationships in which students are working closely, can have an impact on inclusion, bullying/teasing and school climate.
