Section 2: Assurances

- 6. All existing district-owned and operated sites and assets, including temporary classroom units that were not installed to support building construction, are represented in the Site Asset Report.
- 7. Contiguous district-owned or leased parcels of land are represented as one site regardless of the number of schools, functions, or buildings located on the site. (For example, a site with a district administration building and instructional buildings serving two schools should still be represented as one site. The school buildings would have different "schools served" selected.)
