### SYNOPSIS

Petitioning “Abbott” Board of Education appealed the Department of Education’s determination with respect to funding for the district’s 2004-05 preschool program.

Initially, the ALJ determined that this proceeding should encompass issues arising from Board determinations on the budget requests of its contracted private preschool providers, since those determinations were made in conformance with Department directives and it is in the best interest of all involved to resolve the district’s preschool budget in a single proceeding. Of the issues in dispute, only three remained following settlement negotiations between the parties. On the remaining issues, the ALJ rejected one private provider’s request for a second custodian and two private providers’ requests for additional compensation for office staff, but granted, based on the particular circumstances of this matter, that full rather than prorated salary amounts should be funded for teaching staff members assigned to smaller-than-permitted class sizes.

The Commissioner adopted the ALJ’s decision as his own.
