## New Jersey Commissioner of Education

### Final Decision


In the Matter of Donato Marable,  
Board of Education of the City of Beverly,  
Burlington County.

The record of this matter and the decision of the School Ethics Commission (SEC) have been reviewed. The SEC found that respondent violated *N.J.S.A. 18A:12-33* by failing to timely complete the required board member training. The SEC's decision was forwarded pursuant to *N.J.S.A. 18A:12-29* for the Commissioner's final determination on the recommended penalty. The SEC advises that the respondent ultimately completed training after the issuance of the April 26, 2022 Order to Show Cause but prior to the SEC's May 24, 2022 meeting; therefore, a penalty of censure is recommended. Respondent did not file exceptions to the recommended penalty, nor was the SEC's underlying finding of a violation appealed to the Commissioner pursuant to *N.J.A.C. 6A:4*.

Upon review, the Commissioner notes that in previous matters, when a respondent completed the requisite training after the issuance of the Order to Show Cause – but prior to the SEC's meeting date – the penalty has been a reprimand. *See, In the Matter of Annette Beasley, Irvington Board of Education, Essex County, Commissioner Decision No. 223-21SEC, decided October 13, 2021; In the Matter of Marcos Garciga, Cliffside Park Board of Education, Bergen County, Commissioner Decision No. 224-21SEC, decided October 13, 2021; In the Matter of Gary Yedman, Seaside Park Board of Education, Ocean County, Commissioner Decision No. 230-21SEC, decided October 13, 2021.* As the instant case arises from the same circumstances, the Commissioner finds that a reprimand is the appropriate penalty

for the respondent's failure to timely complete the requisite training.<sup>1</sup> Accordingly, the respondent shall be reprimanded as a school official found to have violated the School Ethics Act.

IT IS SO ORDERED.<sup>2</sup>

**I. Procedural History**

This matter arises from an Order to Show Cause (OTSC) that was issued by the School Ethics Commission (Commission) at its meeting on April 26, 2022, and also served on April 26, 2022, via electronic mail.<sup>1</sup> The OTSC directed Donato Marable (Respondent), a “board member” as defined in *N.J.S.A.* 18A:12-23 of the School Ethics Act (Act), *N.J.S.A.* 18A:12-21 *et seq.*, to show cause as to why the Commission should not find him in violation of the Act, for failing to complete training as required by *N.J.S.A.* 18A:12-33 and *N.J.A.C.* 6A:28-4.1.

In the OTSC served on April 26, 2022, the Commission notified Respondent that he had twenty (20) days to respond to the OTSC, and further advised that failure to respond would be deemed an admission of the facts set forth in the OTSC. Respondent was also notified that, upon receipt of the response or upon expiration of the twenty (20) day time period for so filing, the Commission may proceed to a determination of a violation on a summary basis (i.e., without a hearing or further proceedings) in accordance with *N.J.A.C.* 6A:28-1.6(c), which so permits when material facts are not in dispute.

**II. Analysis**

The Act was enacted by the New Jersey State Legislature to ensure and preserve public confidence in members of local boards of education and local school administrators. *N.J.S.A.* 18A:12-33 and *N.J.A.C.* 6A:28-4.1 require every board member to complete a training program prepared and offered by the New Jersey School Boards Association (NJSBA).

Respondent is a member of the Beverly Board of Education (Board), located in Burlington County. As a result of his position on the Board, and in accordance with *N.J.S.A.* 18A:12-33 and *N.J.A.C.* 6A:28-4.1, Respondent is required to complete a mandated training program on an annual basis. For convenience and ease, the training is offered online so any board member may complete it at any time, from anywhere. Respondent was required to complete the Governance 3 training program by December 31, 2021.

On or about April 15, 2022, NJSBA provided the Commission with the names of those board of education members who failed to complete mandated training by December 31, 2021, and the list provided included Respondent. Prior to this time, multiple communications about mandated

training were sent to Respondent from NJSBA through a variety of means, including targeted e-mail messages and postings in *School Board Notes*. More specific information detailing the outreach efforts of NJSBA to communicate with Respondent and/or the charter school lead about mandated training is set forth in the attached Certification from NJSBA. Notwithstanding all of these communications, Respondent did not complete mandated training.

In light of Respondent's failure to complete mandated training, an OTSC was issued by the Commission, and served on Respondent, via electronic mail, on April 26, 2022.

To date, there is no dispute that Respondent did not complete his required training by December 31, 2021, and did not complete the training prior to the issuance of the Commission's OTSC. After having been served with the OTSC, Respondent completed his training requirement on May 5, 2022, and also filed a response to the Commission's OTSC. More specifically, Respondent stated that he "believed that he had completed" the training requirement on December 7, 2021. Upon receipt of the Order to Show Cause, Respondent "immediately contacted [the] Board Secretary" and asked for assistance with registration for the training. Importantly, Respondent did not deny that he did not complete training in a timely fashion.

### III. Decision/Penalty Recommendation

*N.J.A.C.* 6A:28-4.2(d) provides that school board members and charter school trustees who fail to comply with their training mandate shall be considered in violation of *N.J.S.A.* 18A:12-33. Based on the record as set forth above, at its meeting on May 24, 2022, the Commission found that Respondent violated *N.J.S.A.* 18A:12-33 and *N.J.A.C.* 6A:28-4.1. Respondent received repeated notifications of his training requirement, and had ample opportunity to complete the mandated training in a timely fashion; nonetheless, he failed to complete training as required. Where a violation of the Act is found by the Commission, the Commission may recommend to the Commissioner of Education that a penalty be imposed. The recommended penalty can include a reprimand, censure, suspension, or removal of the school official. *N.J.A.C.* 6A:28-10.12.


For the reasons set forth above, and because training is regularly completed annually and can be completed from any computer or device with an internet connection, the Commission recommends that the Commissioner of Education impose a penalty of **censure**.

Pursuant to *N.J.S.A.* 18A:12-29(c), this decision shall be forwarded to the Commissioner of Education for review of the Commission's recommended penalty. Respondent may either: 1) file exceptions to the recommended sanction; 2) file an appeal of the Commission's finding of a violation; or 3) file both exceptions to the recommended sanction together with an appeal of the finding of a violation.

Parties taking exception to the recommended sanction of the Commission but *not disputing* the Commission's finding of a violation may file, within **thirteen (13) days** from the date the Commission's decision is forwarded to the Commissioner, written exceptions regarding the recommended penalty to the Commissioner. The forwarding date shall be the mailing date to the parties, as indicated below. Such exceptions must be forwarded to: Commissioner of Education, c/o Bureau of Controversies and Disputes, P.O. Box 500, Trenton, New Jersey 08625, marked

“Attention: Comments on Ethics Commission Sanction.”<sup>2</sup> A copy of any comments filed must be sent to the Commission ([school.ethics@doe.nj.gov](mailto:school.ethics@doe.nj.gov)) and all other parties.

Parties seeking to appeal the Commission’s finding of violation *must* file an appeal pursuant to the standards set forth at *N.J.A.C. 6A:4:1 et seq.* within **thirty (30) days** of the filing date of the decision from which the appeal is taken. The filing date shall be three (3) days after the date of mailing to the parties, as shown below. In such cases, the Commissioner’s review of the Commission’s recommended sanction will be deferred and incorporated into the Commissioner’s review of the finding of violation on appeal. Where a notice of appeal has been filed on or before the due date for exceptions to the Commission’s recommended sanction (thirteen (13) days from the date the decision is mailed by the Commission), exceptions need not be filed by that date, but may be incorporated into the appellant’s briefs on appeal.



**CERTIFICATION UNDER OATH  
OF MARCIA LAVIGNE**

Marcia Lavigne, being of full age, does hereby certify as follows:

1. I am an employee of the New Jersey School Boards Association and the Senior Manager of Professional Learning. I am responsible for working with NJSBA staff to assure accuracy of board of education member and charter school trustee mandatory training records.
2. Pursuant to N.J.S.A. 18A:12-33, both elected and appointed school board members and charter school trustees (collectively members) are required to complete educational courses regarding the skills and knowledge necessary to serve as a local school board or charter school member. The training program includes information regarding the school district monitoring system established pursuant to P.L.2005, c.235, the New Jersey Quality Single Accountability Continuum, and the five key components of school district effectiveness on which school districts are evaluated under the monitoring system: instruction and program; personnel; fiscal management; operations; and governance.
3. Pursuant to N.J.A.C. 6A:28-4.1(a), during a member's initial year of service, that member is required complete a training program prepared and offered by the New Jersey School Boards Association which shall include in its content instruction relative to the board member's responsibilities under the Act.
4. Pursuant to N.J.A.C. 6A:28-4.1(b), each member is required to complete a training program to be prepared and offered by the New Jersey School Boards Association on school district governance during the second and third years of service on any board.
5. Pursuant to N.J.A.C. 6A:28-4.1(c), each member is required to complete an advanced training program on relevant changes to New Jersey school law to be prepared and offered by the New Jersey School Boards Association during the first year of any re-elective or re-appointive term.

6. As part of my responsibilities as the Senior Manager of Professional Learning, I assure the accuracy of the reports provided to the New Jersey School Ethics Commission (SEC) regarding members who do not complete the above-referenced training.
7. On November 10, 2020 the general election was conducted across the state of New Jersey. Pursuant to N.J.S.A. 18A:10-3(c), boards of education are required to organize as follows: “In all type II districts with a November school election on any day of the first week in January at which time new members shall take office.”
8. According to N.J.S.A. 18A:10-3, each member elected in November 2020 was required to commence their term of office during the first week of January 2021. Pursuant to N.J.S.A. 18A:12-33 and N.J.A.C. 6A:28-4.1, each member commencing a term of office during the first week of January 2021 was required to complete their respective training program within one year of assuming office.
9. On various dates in 2021 board members and business administrators were advised through the NJSBA’s *School Board Notes* digital publication of the obligation to complete mandatory training as follows:

  - d. 1/18/2021
  - e. 1/25/2021

10. Pursuant to N.J.A.C. 6A:28-4.2(c), by March 31 of each year, NJSBA is required to present to the School Ethics Commission a list of those board members and charter school trustees who have not fulfilled the above-specified training requirements.
11. On January 4, 2021, Donato Marable was registered to take Governance training “GOV 3” and an email with the link was sent to their registered email address. An additional email was sent to all board members about mandated training on January 22, 2021
12. On January 7, 2022 notice of non-compliance was emailed from NJSBA offices to the board member email address on file, dmarable@beverlycityschool.org, addressed to the above-referenced board member (Exhibit 1).
13. On January 14, 2022 notice of non-compliance was mailed from NJSBA offices to the board member mailing address on file at the last-known mailing address. (Please note that while this letter indicates that it was sent via registered mail, the letter was delivered via regular mail, no registered letter was sent at this time (Exhibit 2).
14. On March 8, an additional out-of-compliance notice was forwarded to Donato Marable at the last known address on file with the NJSBA. This letter was sent registered and regular mail (Exhibit 3).
15. On March 11, 2022 NJSBA delivered said report of school board members who were elected in November of 2020 but who had not completed their mandated training within their first year of service (Exhibit 4).
16. On or about January 1, 2021, the NJSBA Governance Online Portal has been open and available to Donato Marable to complete mandatory training.
17. As of the date of this certification, NJSBA has no evidence that the in-person or online governance program have been completed, nor has NJSBA received any objection from DonatoMarable indicating that its records are in error.

**CERTIFICATION UNDER OATH**

Marcia Lavigne, of full age, being duly sworn upon her oath according to law deposes and says:

1. I am the complainant in this matter.

2. I have read the complaint and aver that the facts contained therein are true to the best of my knowledge and belief and I am aware that the statute that created the School Ethics Commission authorizes the School Ethics Commission to impose penalties for filing a frivolous complaint. N.J.S.A. 18A:12-29(e). I am aware that if the respondent alleges that the complaint is frivolous, I shall have 20 days from receipt of the answer to respond to the allegation.

3. The subject matter of this complaint is not pending in any court of law or administrative agency of this State. I will advise the School Ethics Commission if I subsequently become aware that it is pending elsewhere.




