Kevin Dehmer Sworn in as Commissioner of New Jersey Department of Education

Trenton, NJ – Kevin Dehmer was today sworn in as Commissioner of the New Jersey Department of Education (NJDOE) following a ceremonial swearing-in hosted by Governor Phil Murphy at the State House.

Commissioner Dehmer has spent more than 17 years in public service with the New Jersey Department of Education, previously serving twice as Interim Commissioner of Education and in other key leadership roles, including Assistant Commissioner for Finance/Chief Financial Officer.

"Kevin Dehmer's steadfast leadership and commitment to education in New Jersey have been instrumental in advancing policies that support students, educators, and families across the state," **said Governor Murphy**.
