




Office of Professional Learning: Connected Action Roadmap (CAR) Framework

- Highly-skilled educators with content-specific expertise
- Professional Learning Communities
- Shared leadership in schools and districts
- Preparation programs for school leaders and new teachers

Timeline: ELA & Math Instructional Units

- January 2019
 - Begin collaboration with partners and ELA & Math educators to unpack standards using the CAR process
- February-March 2019
 - Host regional information sessions to introduce the CAR model, share resources with school districts, and help districts explore their capacity for next steps.
- April 2019
 - Release instructional units to participating school districts to use within their Professional Learning Communities.

Our Vision to Review & Revise Standards

- Design and implement a coherent, transparent, and systematic approach to the standards review process using evidence-based practices.
 - Design 2-way communication
 - Professional learning experiences for writing teams and NJDOE staff
 - Create high-quality standards
 - Engage in State Board Approval Process
 - Build capacity
 - Reflect and Refine



Proposed Timeline for Standards Review & Revise

- January 2019
 - Select standards review teams for each content area
- February-July 2019
 - Review and revise NJSLS based on protocols and research
- September-October 2019
 - Seek and respond to feedback from focus groups (e.g., educators, professional organizations)
- November 2019-May 2020
 - Consideration by State Board, Public Comment
- June 2020
 - Approval by State Board
