**Convening**

State Board of Education President Kathy Goldenberg convened the public meeting at 9:20 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

### **Public Testimony**

### **Resolution in Honor of Gifted and Talented Students Month in New Jersey**

On a motion duly seconded and carried, the State Board unanimously approved the following resolution read by State Board member Fatimah Burnam-Watkins:

#### **Resolution in Honor of Gifted and Talented Students Month in New Jersey**

**Whereas**, the "Strengthening Gifted and Talented Education Act" was signed into law on January 13, 2020, and

**Whereas**, the Act defines a Gifted and Talented Student as one who possesses or demonstrates high levels of ability in one or more content areas when compared to their chronological peers and who require modification of their educational program to achieve in accordance with their capabilities; and

**Whereas**, the Act specifies standards for Gifted and Talented education student identification, services, professional development, and reporting of student counts disaggregated by race, gender, special education designation, and English language learner designation; and

**Whereas**, Gifted and Talented Students may also be Twice-Exceptional, or give evidence of a special need or disability as defined by Federal or State eligibility criteria; and

**Whereas**, the full intellectual and academic potential of Gifted and Twice-Exceptional Students is developed and bolstered through the guidance of trained educators who develop specialized learning services through the local school district, extracurricular programs, and parent collaboration; now, therefore be it

**Resolved**, that the New Jersey State Board of Education and the Commissioner of Education recognizes the month of March as "Gifted and Talented Students Month in New Jersey" and honors the gifted and talented students of New Jersey, the parents, and the teachers who are working to ensure that these young people have the resources and opportunities they need to succeed.

The Perkins V plan is one tool for building a pathway to post-secondary success for students.

**\*C. Resolution to Accept Donated Funds**

- Adopted the following the resolution approving the acceptance of up to \$75,000 in donated funds.

**Resolution to Accept Donated Funds**

**Whereas**, the New Jersey Department of Education is the recipient of a donation from the New Jersey Education Association (NJEA); and

**Whereas**, N.J.S.A. 18A:4-26 requires the approval of the New Jersey State Board of Education in order for the Commissioner of Education to accept donated funds; and

**Whereas**, the following donation was made from NJEA:

\$75,000 – *Amistad Journey*. These funds are restricted to experiential learning opportunities for educators to travel to sites related to the trans-Atlantic slave trade and to learn about how to incorporate that experience and information into their teaching across the curriculum; now therefore be it

**Resolved**, that the New Jersey State Board of Education approves the acceptance of the donated funds for the aforementioned specified purposes.

**\*D. Resolution to Adopt Revised Qualifying Scores for State-Issued High School Diplomas**

- Adopted the following resolution pursuant to N.J.A.C. 6A:20-1.4(a) recommending the revised qualifying scores for their respective tests for the granting of state-issued high school diplomas. State Board member Andrew Mulvihill opposed.

**A Resolution to Adopt The Revised Qualifying Scores for State-Issued High School Diplomas**

**Whereas**, the New Jersey State Board of Education (State Board) has required that adult education students pass all sections of one of the New Jersey High School Equivalency Assessments in accordance with N.J.A.C. 6A:8-5.2 and 6A:20-1.4.

**Whereas,** the State Board in 2013 adopted three different tests (GED, HiSET, and TASC), which qualify a person for a State-issued high school diploma, and each test's initial qualifying scores; and

**Whereas,** after the test's initial qualifying scores were adopted by the State Board, the General Education Development (GED) had established in 2016 the passing score per subject to be 145; and

**Whereas,** the High School Standard Equivalency Test (HiSET) also established in 2014 that the passing score per subject to be 8, with a total battery score of 45; and

**Whereas,** the passing score of 9 instead of 500 per subject was adopted in 2014 for the Test Assessing Secondary Completion (TASC); and

**Whereas,** in 2019 the Department researched the studies of the passing scores of GED and HiSET to determine the validity of and the theoretically appropriate passing scores for those tests; and

**Whereas,** based on this research, the Department recommends to the State Board that revisions be made to the qualifying scores for the GED, HiSET and TASC and that those passing scores for the GED and HiSET be applied now and retroactively from 2014; and

**Whereas,** the Department will monitor the impact of these new qualifying scores on the passing rates for each subject area and will report any problems with the same to the State Board; and now therefore be it

**Resolved,** that the State Board hereby approves the Department's recommendation to adjust the qualifying scores for the GED, HiSET and TASC and that those passing scores for the GED and HiSET be applied now and retroactively from 2014; and be it further

**Resolved,** that the New Jersey State Board of Education hereby acknowledges and approves the following passing scores, effective March 4, 2020:
