# Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:05 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

#### **Election of State Board Officers**

On motions duly seconded and carried, the State Board members unanimously elected Kathy Goldenberg as State Board President and Andrew Mulvihill as State Board Vice President. Both were elected for a one-year term.

She also stated that she looks forward to apprising the State Board of issues that concern students and, likewise, ensuring all students are more aware of the happenings of the State Board.

# Report of the Comprehensive Accountability Office and the Highly Skilled Professional

Chris Huber, Special Assistant, Caitlin Pletcher, Regulatory Analyst, and Anzella Nelms, the Highly Skilled Professional, shared the findings of the Report of Comprehensive Accountability Office and the Report of the Highly Skilled Professional to demonstrate through the Scorecard and the reports that the Newark Public School District has met the objectives and benchmarks established in its Transition Plan and is poised to assume full local control.

Resolution to Return the City of Newark Public Schools to Local Control

 On a motion duly seconded and carried, the State Board unanimously adopted the following resolution pertaining to the status of state operation of the Newark Public Schools.

# Resolution Returning The Newark Public School District To Full Local Control

**Whereas,** by administrative order issued on July 5, 1995, the State Board of Education removed the Newark Public School District Board of Education and created a State-Operated School District in Newark, pursuant to N.J.S.A. 18A:7A-34; and

Whereas, pursuant to N.J.S.A. 18A:7A-10 et seq. and effective January 24, 2007, the New Jersey Legislature directed the Commissioner of Education to develop and implement, after review by the Joint Committee on the Public Schools, a system for monitoring and evaluating the thoroughness and efficiency of public school districts in the State of New Jersey to be called the New Jersey Quality Single Accountability Continuum (NJQSAC); and

Whereas, NJQSAC involves an assessment of each school district's performance in the five key components of school district effectiveness: Instruction and Program, Personnel, Fiscal Management, Operations, and Governance; and

Whereas, the State Board of Education adopted resolutions on October 17, 2007, June 4, 2014, and August 3, 2016, to return to local control the areas of Operations, Fiscal Management, and Personnel, respectively, while the remaining key components of school district performance continued under partial State intervention; and

Whereas, the State Board of Education adopted a resolution on September 13, 2017, to initiate the return to local control of the key components of Governance and Instruction and Program; and

Whereas, in accordance with N.J.A.C. 6A:30-7.1, the Commissioner determined that the Newark Public School District met the factors for initiating withdrawal from partial intervention and a return to full local control; and

**Whereas,** in accordance with N.J.A.C. 6A:30-7.2, the Commissioner recommended to the State Board of Education that the process for withdrawal from partial intervention be initiated in Newark Public School District; and

Whereas, the State Board of Education adopted a resolution on September 13, 2017, directing the Department of Education, in collaboration with Newark Public School District, to develop a full transition plan, pursuant to N.J.A.C. 6A:30-7.2 and 7.3, and to initiate the process of withdrawal of the Newark Public School District from partial State intervention; and

**Whereas,** in collaboration with the Newark Public School District and pursuant to N.J.A.C. 6A:30-7.2 and 7.3, the Department of Education developed a full transition plan, which established the framework for the return to local control of the school district and went into effect on February 1, 2018; and

Whereas, pursuant to the transition plan, the Commissioner appointed a Highly Skilled Professional, Ms. Anzella Nelms, to provide the Newark Public School District with technical assistance in implementing the transition plan, to serve as a liaison between the school district and the Department of Education, and to provide qualitative observations regarding the school district's progress under the transition plan; and

Whereas, pursuant to the transition plan, the Department of Education partnered with an independent entity, the Bloustein Local Government Research Center of Rutgers University, to form a Comprehensive Accountability Office (CAO); and

Whereas, pursuant to the transition plan, the CAO was tasked with collecting, analyzing and publishing data regarding the ongoing operations and performance of the school district and the school district's quantitative progress in implementing the transition plan, as measured by metrics on an Accountability Scorecard; and

Whereas, the CAO completed three reports regarding the school district's progress in implementing the transition plan -- the initial report, a progress report, and a final report; and

Whereas, the CAO's final report confirms that the school district successfully completed the quantitative metrics on the Accountability Scorecard and fulfilled the requirements of the transition plan; and

Whereas, Ms. Nelms, the Highly Skilled Professional, completed four reports regarding the school district's progress in implementing the transition plan and her final report confirms that the school district fulfilled the requirements of the transition plan and has developed systems and processes to sustain the school district's practices and progress; and

Whereas, pursuant to N.J.A.C. 6A:30-7.6, the Commissioner has determined that the Newark Public School District has successfully implemented the full transition plan and, therefore, recommends to the State Board of Education the withdrawal from State intervention be completed and the Newark Public School District be returned fully to local control; and be it

**Resolved,** that the State Board of Education approves the withdrawal of the Newark Public School District from State intervention; and be it further

**Resolved,** that the State Board of Education, on the first day of July in the year 2020, hereby approves that the Newark Public School District is now returned fully to local control.

# Certification of the District as High Performing

 Certified the Newark Public School District as High Performing for a period of three years, as recommended by the Commissioner, pursuant to N.J.S.A. 18A:7A-14.a and b.

Resolution in Honor of Dr. Lamont O. Repollet, Commissioner of Education

On behalf of the State Board, President Goldenberg presented Commissioner Lamont O. Repollet, Ed.D., with a resolution honoring him for his service to the Department of Education. Commissioner Repollet is resigning after serving as Commissioner of Education since January 2018 to become the 18<sup>th</sup> President of Kean University. The State Board also honored the Commissioner with a slide show highlighting many special moments during his tenure as Commissioner of Education.

On a motion duly seconded and carried, the State Board unanimously approved the following resolution read by State Board President Kathy Goldenberg:

# Resolution to Honor Commissioner Lamont O. Repollet, Ed.D.

**Whereas,** Dr. Lamont O. Repollet has served with distinction as the New Jersey Commissioner of Education from January 2018 to the present and is being honored for his distinguished tenure of service; and

**Whereas,** as Commissioner, Dr. Repollet demonstrated his heartfelt concern for the education and welfare of students by visiting more than 150 schools throughout all 21 counties to speak directly with students, parents and educators to receive their feedback on New Jersey's public education system; and

**Whereas,** Dr. Repollet shifted the perception of the New Jersey Department of Education from being compliance driven by extending an olive branch with his "boots on the ground" approach to school district, school and educator supports; and

Whereas, Dr. Repollet played a leading role in the management of the expansion of high-quality preschool programs across New Jersey, the increase of career and technical education opportunities for thousands of students, including the introduction of the P-TECH model at four New Jersey high schools, the development of Computer Science for All programs in numerous school districts, as well as the equitable distribution of millions of dollars in new State aid from 2018-2020 to help school districts provide each and every student with high quality education regardless of their zip code; and

Whereas, Dr. Repollet's steadfast commitment to providing educational equity led the Department to develop policies and initiatives to address inequities that create barriers to student success, to focus on a continued analysis of what all students need and the best methods to provide students with equitable access to the necessary supports for learning and social emotional well-being; and

Whereas, Dr. Repollet's unwavering belief in collaboration, consensus building and problem solving has led to the implementation of innovative initiatives, such as the Amistad Journey, Connected Action Roadmap (CAR) model implementation, and Unified Sports Program, and significant improvements to the New Jersey Student Learning Standards; and

Whereas, Dr. Repollet's focus on the importance of diversifying New Jersey's teacher workforce and his recognition of the benefits that a diverse teaching corps presents for students and for the profession has enabled school districts to have access to, and students to be taught by, well-trained, effective educators who meet the particular needs of local communities; and

**Whereas,** through innovative and system-driven initiatives, Dr. Repollet led the Department to hold the distinguished honor of being named by *Education Week* in September 2019 as the best education system in the nation; and

Whereas, throughout the COVID-19 pandemic, Dr. Repollet helped New Jersey's educators and students navigate the challenges of transitioning to remote learning and diligently worked to ensure that our school communities continue to receive the supports necessary to move through this unprecedented time and safely move to reopen schools; and

**Whereas,** as Commissioner, Dr. Repollet provided critical guidance and leadership to the Newark Public School District during the two-year transition period that successfully enabled the school district to fulfill its plan to return to full local control after 25 years under State intervention; and

**Whereas,** Dr. Repollet is resigning his post as the New Jersey Commissioner of Education to become the 18th President of Kean University; now therefore be it

**Resolved,** that it is both fitting and proper that the New Jersey State Board of Education express its sincere gratitude to Dr. Lamont O. Repollet for his dedicated leadership as Commissioner, which was exemplified by the collegial manner in which he worked with the State Board and all stakeholders to provide a challenging, nurturing learning environment for all students; and be it further

**Resolved,** that the New Jersey State Board of Education hereby honors Dr. Lamont O. Repollet for his esteemed record of service to the State and extends best wishes for success and happiness in his new endeavor.
