# Convening

State Board member Mary Beth Berry asked for an update on the Digital Divide. She also asked if school districts need to include technology plans in their school district reopening plans. She further asked if the Department gathers information on the successes and/or failures of Extended School Year programs.

State Board President Goldenberg asked how far along in the process the Executive County Superintendents are in approving school district reopening plans. She also asked if the majority of school districts are going to be implementing remote or hybrid options. She further asked as COVID 19 cases may arise in school districts will that information be made public.

State Board member Fatimah Burnam-Watkins asked if there is a timeframe whereby school districts have to make decisions or declare plans for the reopening of the school district?

State Board member Ronald Butcher stated that four topics were brought up at today's meeting that he recommended be discussed further in committees: Adult High Schools, Teacher Preparation and Certification, the Digital Divide and Communicating the Student Voice to the Public.
