





\*\*In 2016 and 2017 the method of collecting data was different and only the counts of students who utilized the portfolio appeals process for both ELA and math were collected. There is no immediate way to distinguish the unique number of students participating in the portfolio appeals process for these years.



## Impacts on Students

Effects on Students for retaining the 750-cut score

- Emotional concerns for some students, especially students who have never missed a target previously.
- Limits the number of elective courses in which a student may participate.
- Possible exclusion of a student to participate in some programs such as Career and Technical Education and School-to-Work programs.



### **Impacts on Districts**

### Effects on Districts:

- Increased burden on the district to:
  - schedule Portfolio Appeals courses,
  - complete and file the paperwork for each portfolio appeal,
  - complete appeals early to ensure student participation in commencement activities.



Recommendation from the Department regarding cut scores for the NJGPA and the Menu of Alternate Assessments



## Recommendation

- NJGPA Cut Score
  - Establish the cut score at the 725 mark.
- Alternate Assessment Cut Scores
  - Establish the cut scores to represent the results of the alignment study to the NJGPA 725 cut score.





- The data finds that a 750-cut score lowered passing rates on the alternative assessments and increased the probability that significantly more students will graduate through the portfolio appeal process.
- The impact of the Covid-19 Public Health Emergency greatly impacted mental health and wellness and setting our graduation requirements at the 725-cut score is prudent
