## Strengthening Gifted and Talented Education Act

- On January 13, 2020, Governor Murphy signed the Strengthening Gifted and Talented Education Act into law.
- The Act codified local educational agencies' (LEA) responsibilities in educating G&T students and the requirements for reporting data about their programs.
- The legislation went into effect at the beginning of the 2020-2021 school year.






## Requirements of the Act



#### LEAs are required to ensure:

- Appropriate instructional adaptations and educational services;
- Ongoing, inclusive, identification process;
- Development and documentation of curricular and instructional modifications made for G&T students;
- Utilization of resources from the National Association for Gifted Children; and
- The provision of time and resources for professional learning.




## Reporting Requirements of the Act (1 of 2)



The Act requires a Service Report be submitted every three years, including:

- Qualitative data about the district's G&T policies and procedures;
- Demographic information about G&T students;
- Professional development opportunities provided; and
- Number of teachers, educational service staff, and school who work to identify and provide service to G&T students.






## Reporting Requirements of the Act (2 of 2)

- The Act also requires data be submitted annually through the Fall data collection in NJSMART.
- The collection includes the number of students receiving gifted and talented services in each grade level kindergarten through grade 12 disaggregated by:
  - o race;
  - o gender;
  - o special education designation; and
  - o multilingual learner designation.





## Website Requirements



LEAs are required to post policies and procedures, as well as the continuum of services offered to gifted and talented students. They must include:

- Criteria for eligibility, description of the multiple measures used in the identification process, and the timeline;
- The full continuum of services offered to G&T students;
   and
- The complaint and compliance policy adopted by the local board of education.



## Graph of G&T by Race and Ethnicity









