Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:16 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

President's Reports

Public Testimony

President Goldenberg stated that for the month of June, the State Board will not receive public testimony as there are no educational topics for discussion.

President Goldenberg stated that for the month of July, the State Board will receive public testimony on the proposed amendments to Chapter 27, Student Transportation. President Goldenberg also stated that she along with State Board members Mary Beth Berry, Jeanette Peña Claudine Keenan would her public testimony in July.

Administrative Policy Committee Meeting

Elaine Bobrove, chair of the Administrative Policy Committee, stated that the committee met on May 29, 2025, to discuss PRAXIS II Resolution, Revised Tests and Qualifying Scores. She stated PRAXIS are a group of tests given to those to assess prospective Instructors (Teachers) as to their ability to teach in different fields. She further stated ETS is an organization that sets cut scores that are satisfactory to the majority of Stated so that Instruction is uniform among the majority of States and over time, some skills are automatic and no need to be specifically included while others need to be added. Ms. Bobrove stated In PRAXIS II, three domains are addressed; Technology and Engineering Education; Family and Consumer Science; and Social Studies. She stated that today the Department of Education will be discussing this more fully before it is voted on.
